NOTICE GIVEN UNDER SECTION 708(5) of the CORPORATIONS ACT

This notice is given by **Antilles Gold Limited (ASX Code: AAU) ("Antilles Gold" or the "Company")** under section 708(5)(e) of the Corporations Act 2001 (Cth) (**Corporations Act**).

The Company has issued 142,857,143 ordinary fully paid shares at an issue price of A\$0.014 per share, and 71,428,572 attaching unlisted options (exercisable at 3 cents each expiring on 31 December 2027) to Mr Yue Xiao as announced to ASX on 17 April 2026.
