	Yes, on 24 October 2025 the Company raised a further \$500k by the issue of 2,994,012 ordinary shares at an issue price of \$0.167 per share. Additionally, the Company expects to receive a further \$4m by the sale of a Royalty based on future product sales from its Sandy Mitchell project. This is highly likely to occur, Refer ASX announcement of 25 August 2025 for details.
