Completion of Share Placement and Cleansing Notice

Alma Metals Limited ("Alma" or the "Company") (ASX: ALM) advises that it has today issued 31,800,000 fully paid ordinary shares ("Tranche 2 Shares") at \$0.01 per share as Tranche 2 of the placement announced on 6 May 2026 ("Placement"), having received proceeds of \$318,000 (before costs). The Tranche 2 Shares were issued to the four Directors of Alma following approval of shareholders at a general meeting held on 22 June 2026.

The Company completed the issue of the Tranche 2 Shares on 29 June 2026 without disclosure to investors under Part 6D.2 of the Corporations Act 2001 (Cth) ("the Act").

 - (A) the assets and liabilities, financial position and performance, profits and losses and prospects of the Company; or
 - (B) the rights and liabilities attaching to fully paid ordinary shares.
