Notice of change of interests of substantial holder

We act for Diamond Infraco 1 Pty Ltd (ACN 657 874 363) (**Bidder**), a wholly-owned subsidiary of IFM Global Infrastructure Fund, in connection with the off-market takeover offer by Bidder to acquire all of the Atlas Arteria Securities that it does not currently own (the **Offer**).

Capitalised terms that are not defined in this letter have the meaning given to them in the bidder's statement lodged by Bidder with ASIC and ASX on 27 April 2026 (as supplemented or replaced from time to time) (**Bidder's Statement**).

We enclose an ASIC Form 604 (*Notice of change of interests of substantial holder*) (the **Notice**) on behalf of the IFM Group (as that term is defined in the Notice).

Bidder's Aggregate Interest

Since IFM Group's previous substantial holder notice, the aggregate number of Securities in respect of which:

- Bidder has a Relevant Interest (including as a result of acceptances under the Offer); and
- Acceptance Instructions (in the form of acceptance forms and/or directions to custodians to accept the Offer) are held subject to the Institutional Acceptance Facility,

as a percentage of the total number of Securities on issue, has changed from 34.48% to 38.26% (as at 7.00pm (Sydney time) on 15 June 2026).

Accordingly, the Securities in which Bidder has a Relevant Interest (as set out in the table above) do not include the Securities the subject of Acceptance Instructions, in accordance with section 609A of the Corporations Act.

Immediately after Bidder delivers the Confirmation Notice to the Institutional Acceptance Facility Operator, the Institutional Acceptance Facility Operator must release those Acceptance Instructions. Bidder will acquire a relevant interest in the Securities the subject of the Institutional Acceptance Facility once those Acceptance Instructions are released.

Further details regarding the Institutional Acceptance Facility are set out in sections 6.12 and 7.4 of the Bidder's Statement.

Securities held by Listed Equities Funds, in which Bidder does not have an interest

The Notice discloses that a further 1.34% of Securities are held by or on behalf of clients of IFM Investors and/or IFM Nominees in Listed Equities Funds. For the avoidance of doubt, Bidder has no Relevant Interest or Voting Power in the Securities held by or on behalf of the Listed Equities Funds.

ASIC Instrument 26-0334 – Exemption under paragraph 655A(1)(a) of the Corporations Act

IFM Investors and IFM Nominees manage or act as trustee for the Listed Equities Funds – each an entity or fund which holds, directly or through a custodian, a portfolio of listed securities managed by IFM Investors under an investment management agreement.

IFM Investors, IFM Nominees and the Listed Equities Funds have received an ASIC exemption in relation to the Takeover Bid pursuant to ASIC Instrument 26-0334, made by ASIC under paragraph 655A(1)(a) of the Corporations Act (**ASIC Instrument**). The ASIC Instrument permits IFM Investors and IFM Nominees, in their capacity as manager or trustee of the Listed Equities Funds, to acquire further interests in Securities without breaching section 606 of the Corporations Act, provided that such acquisitions do not result in the Listed Equities Funds' voting power in Securities arising from any acquisitions made by IFM Investors or IFM Nominees in their capacity as manager or trustee of the Listed Equities Funds exceeding 3% more than the amount the Listed Equities Funds held immediately after lodgement of the bidder's statement by Diamond Infracore 1 with ASIC and ASX on 27 April 2026 (as supplemented or replaced from time to time) (**Bidder's Statement**).
