# Appointment of Chair and Board Update

Boss Energy Limited (ASX: BOE; OTCQX: BQSSF) is pleased to announce the appointment of Mr Peter Botten as an Independent Non-Executive Director and Chair of the Company, effective 30 September 2026.

Mr Botten is a highly respected business leader with more than 45 years of experience in the energy and resources sectors. He is best known for his leadership of Oil Search Limited, where he served as Managing Director and CEO for more than 25 years and led the company through a period of significant growth, including the development of the PNG LNG Project, one of the largest resource developments in the Asia-Pacific region.

Mr Botten has also had considerable experience in governing and growing ASX-listed companies. He is currently Chair of Conrad Asia Energy Ltd and Karoon Energy Ltd. He has also held Chair roles for Aurelia Metals Ltd and AGL Energy in the past.

Mr Botten commenced his career as a geologist in the uranium industry with COGEMA, the French Government's atomic energy agency.

Current Chair Mr Wyatt Buck will remain Chair of Boss Energy until the commencement of Mr Botten, after which he will transition to the role of Independent Non-Executive Director.

Outgoing Chair Mr Wyatt Buck commented: *"It has been a privilege to serve as Chair of Boss Energy over the past three years, overseeing the transition of the Honeymoon Uranium Operation from development into production."*

During her tenure, she has made significant contributions to the development of the Company's remuneration framework, as well as providing guidance on talent acquisition and people management.
