NOTICE UNDER SECTION 708A(5)(e)

On 13 January 2026, BPM Minerals Limited (**Company**) issued 1,100,000 fully paid ordinary shares in the capital of the Company. These shares were issued in relation to the conversion of performance rights.

The Company gives notice pursuant to section 708A(5)(e) of the *Corporations Act 2001* (Cth) (**Corporations Act**) that:

 - ii. the rights and liabilities attaching to the Shares.
