Correction to Appendix 3X lodged for John Nowlan on 20 November 2025

BlueScope Steel Limited (ASX: BSL) (the **Company**) advises that the attached Appendix 3X – Initial Director's Interest Notice for John Nowlan replaces the Appendix 3X lodged with ASX on 20 November 2025.

The replacement Appendix 3X includes disclosure of 39,530 Share Rights held by Mr Nowlan, which were granted to him as part of his remuneration while he was an executive employee of the Company prior to his appointment to the Board. The Share Rights were inadvertently omitted from the original Appendix 3X disclosure.

The replacement Appendix 3X retains the previous disclosure of 121,714 Ordinary Shares held by Mr Nowlan. It also retains the previous disclosure of 35,647 Ordinary Shares held by Mr Nowlan's spouse (a related party) for transparency, though Mr Nowlan acknowledges he does not have a relevant interest in those shares.

The Company and Mr Nowlan are aware of their obligations under ASX Listing Rules 3.19A and 3.19B to provide the information necessary for the Company to meet its disclosure requirements, have processes in place to meet those obligations, and consider this oversight to be an isolated administrative error.
