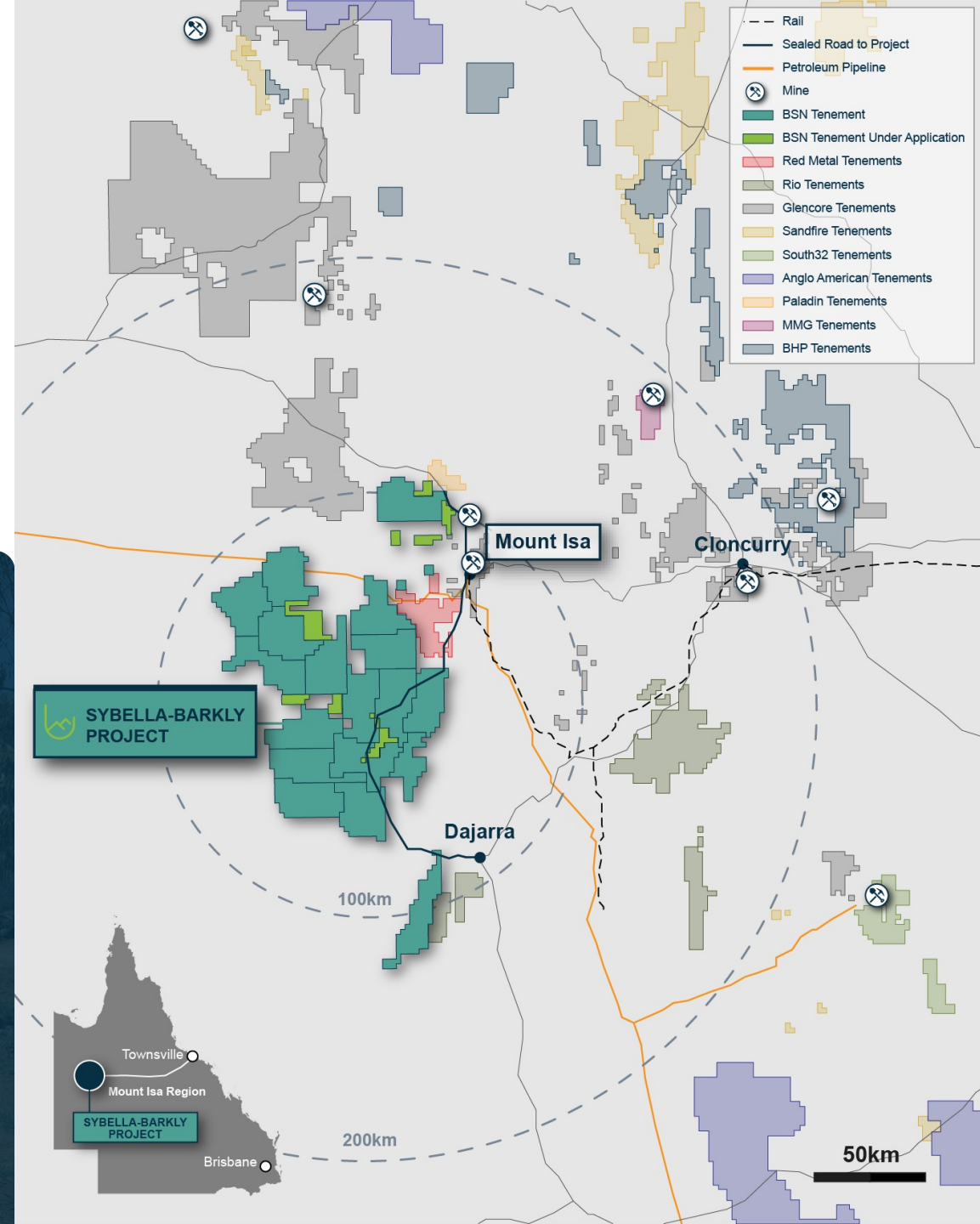

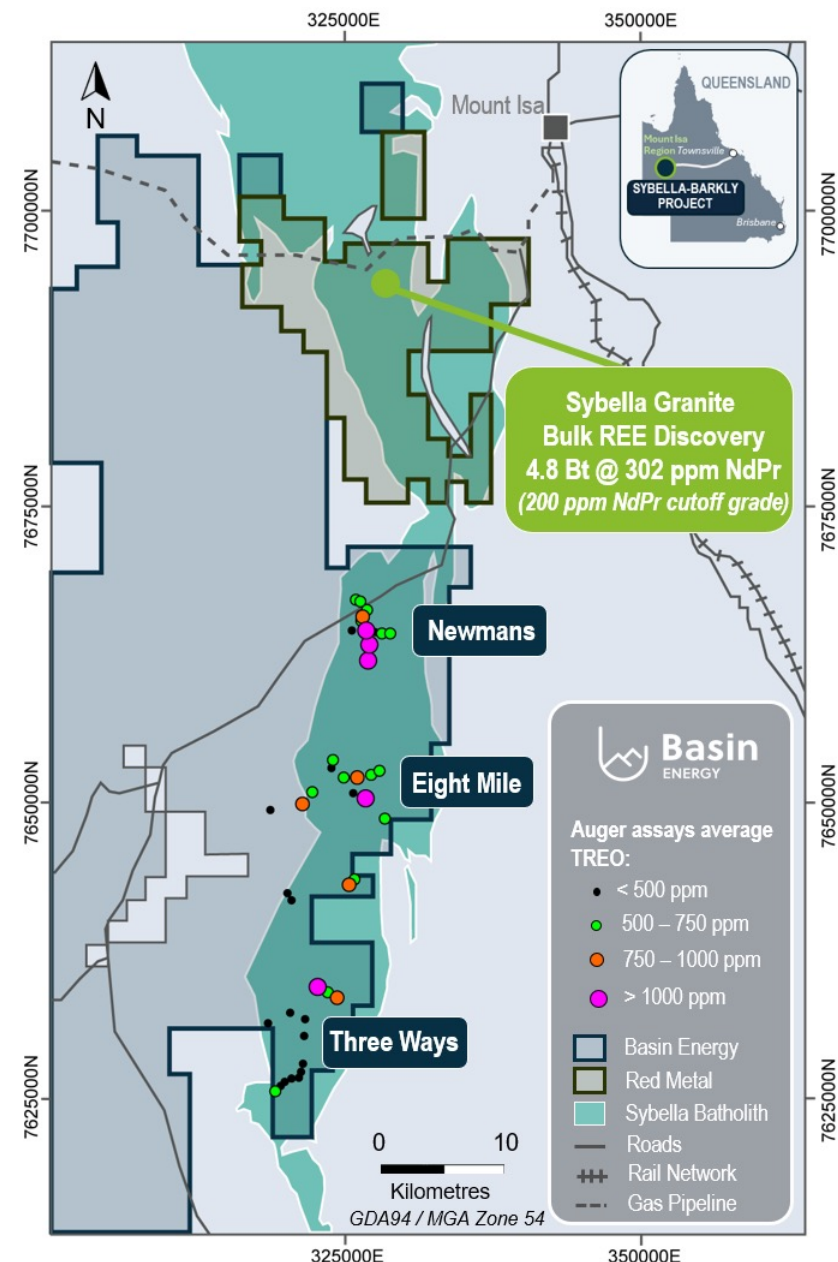

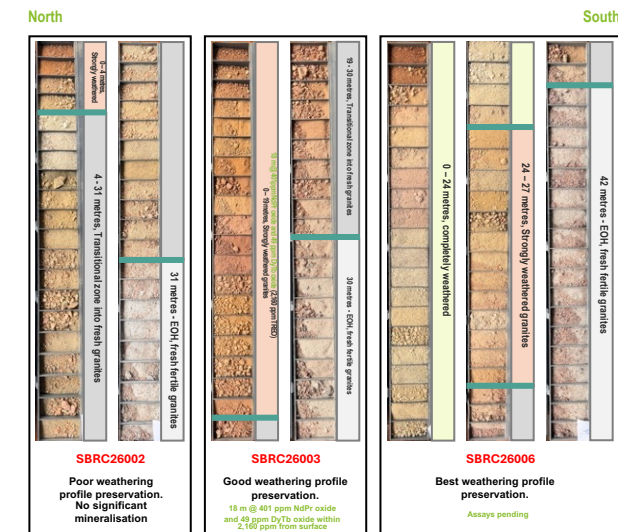

Red Metal (ASX: RDM) drilled beneath a comparable auger anomaly and defined a 4.8 Bt system. Basin's maiden drilling has now returned high-grade magnet REE from surface on the same batholith.

Why this analog matters

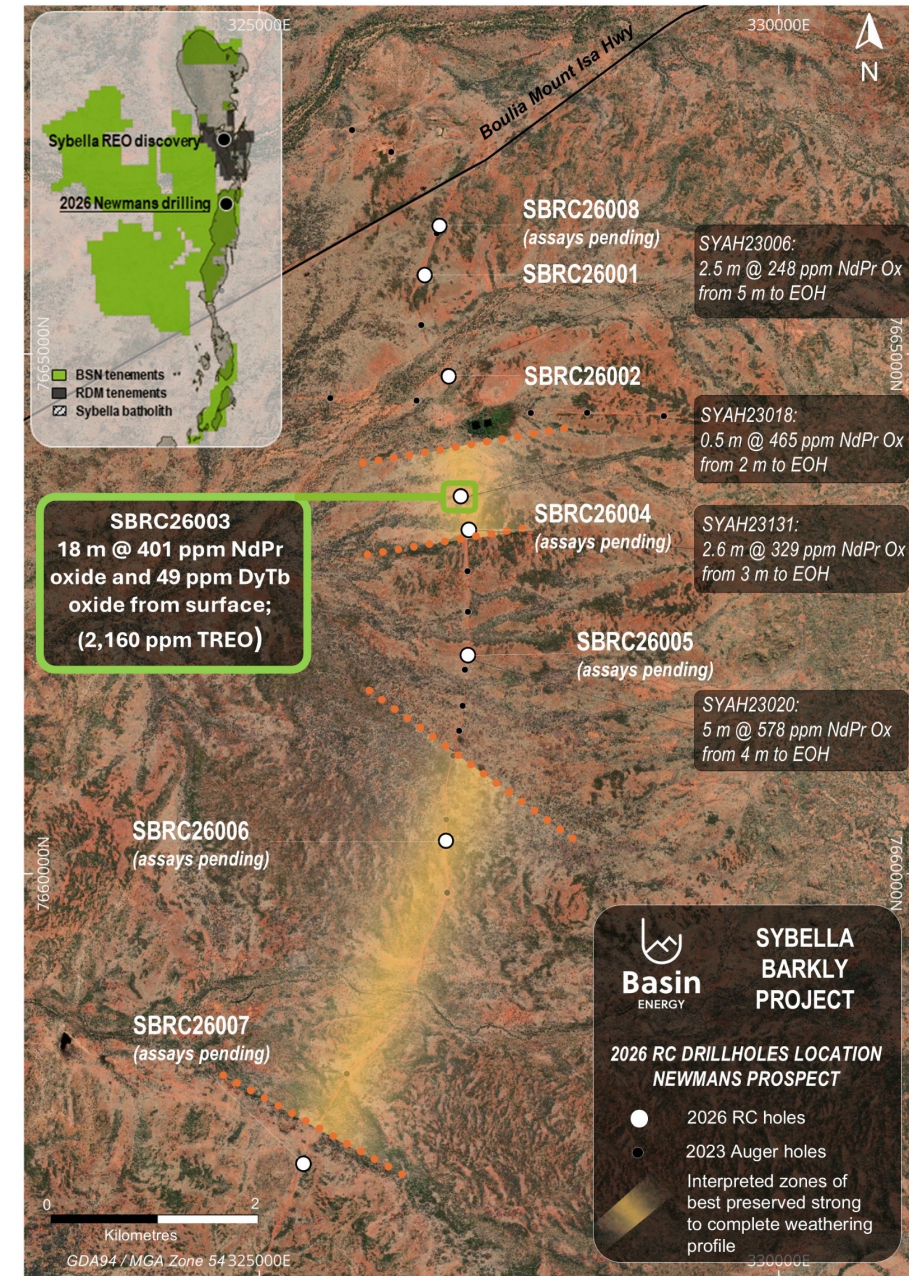
Same host granite system: the Sybella Batholith - a single 180 km x 15 km granite body, 2-3x REE-enriched vs 'normal' granites

Results from first three RC holes at Newmans suggest variation in model to Red Metal, demonstrating weathering profile rare earth enrichment providing strong NdPr, DyTb and Y numbers throughout the weathered granite profile

ANSTO-validated heap-leach metallurgy on RDM material from the Sybella demonstrates the processing route is technically feasible for granite-hosted REE in this district

Maiden drilling has now returned high-grade magnet REE from surface at Newmans - the model open along a ~4 km corridor, with 5 holes still pending

District-scale footprint: BSN tenure covers ~685 km² along the Sybella Batholith, with multiple untested regional target corridors still to be drilled

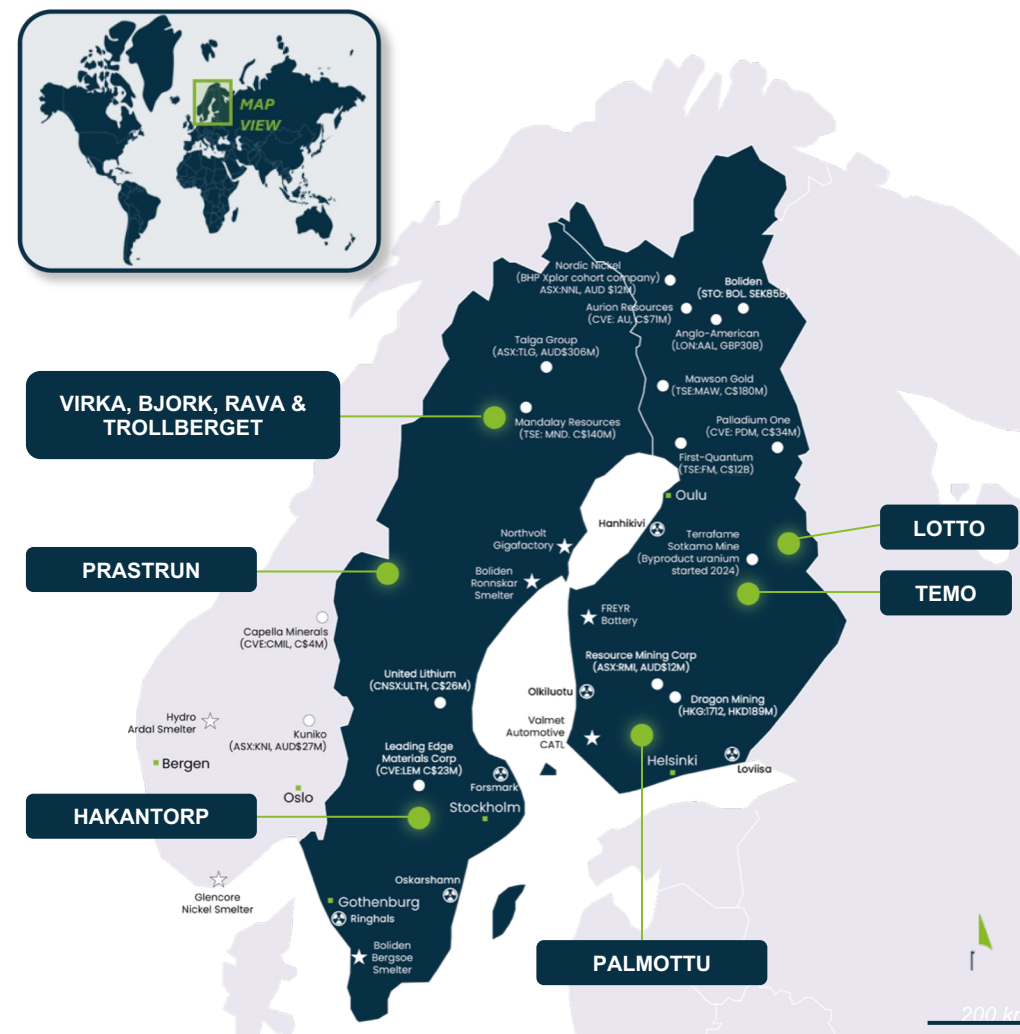

VIRKA + TROLLBERGET, SWEDEN

Documented high-grade uranium, drill-ready continuity

~200 km² across four projects in the Arjeplog-Arvidsjaur uranium district

Historical state-funded drilling (1970s-80s) confirmed uranium occurrences across Virka, Ravaberget and Bjorkberget. Over 10,000 m of legacy core from the broader district located by Basin and used for structural logging, interpretation and sampling.

Basin Energy's sampling of Trollberget legacy core reported **14.4 metres @ 0.15% U₃O₈** in the north, and **12 metres at 0.12% U₃O₈** in the south of the project demonstrating grade and thickness potential.

Basin's best rock chip samples sit between this historical drilling. The district continuity remains largely untested.

Thin glacial cover and accessible terrain - ready for systematic modern drilling now the ban is lifted.

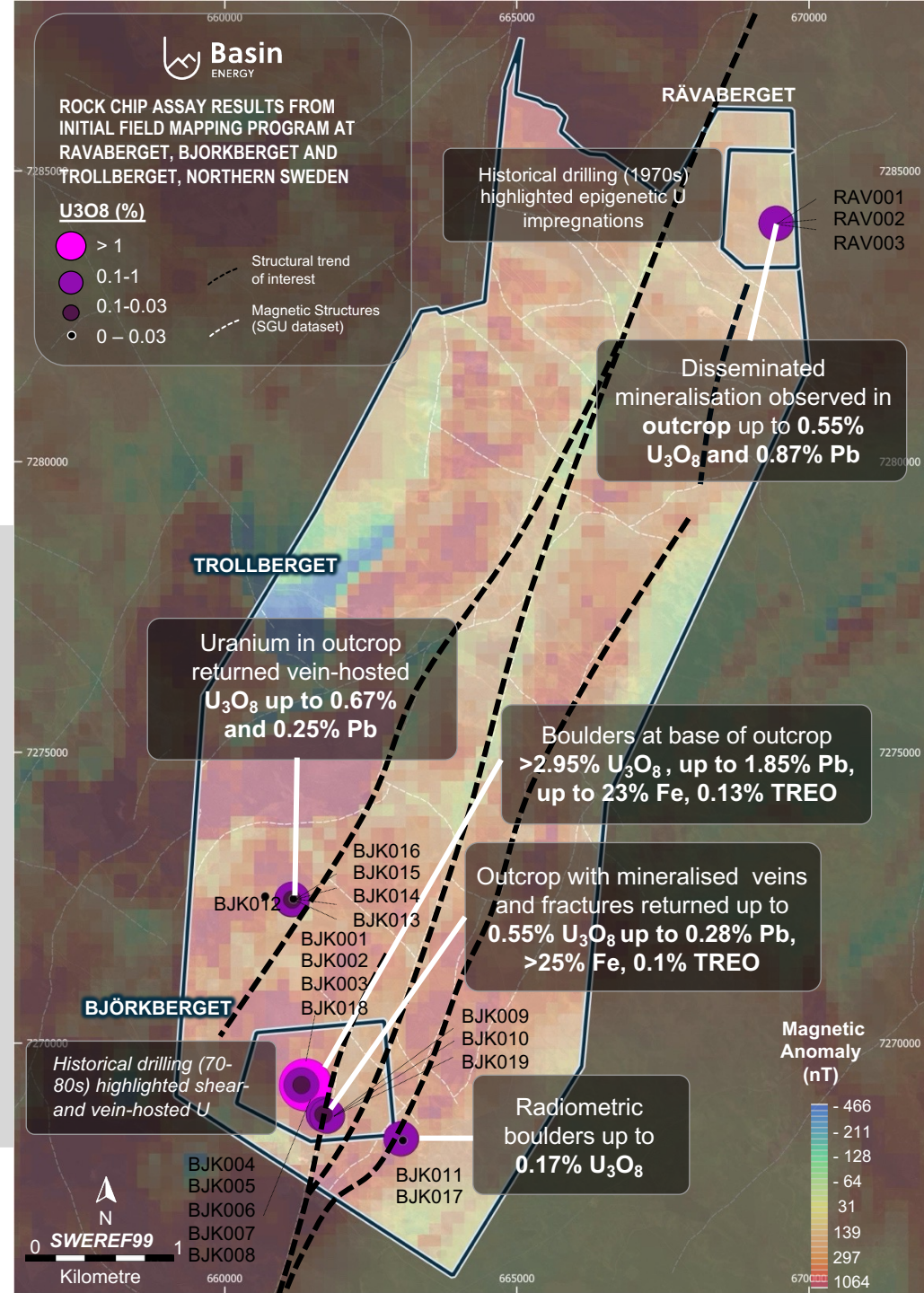

Nuclear renaissance meeting reactor buildouts

Governments now actively backing new-build programs, fuel security and SMRs. Policy momentum accelerating, not slowing.

AI and data centres

Are driving a structural surge in baseload demand. Nuclear is the only scalable zero-carbon solution (WEF, April 2026).

Geopolitical risk

20% of global oil supply exposed to Hormuz disruption is tightening the uranium supply outlook and lifting the premium on Western-aligned production.

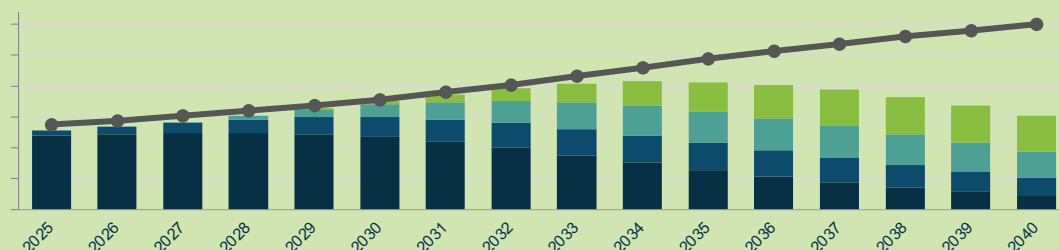
Widening deficit

NdFeB use to more than double by 2050; ~60kt of additional NdPr oxide needed by 2035, more than one Nolans-scale project every year.

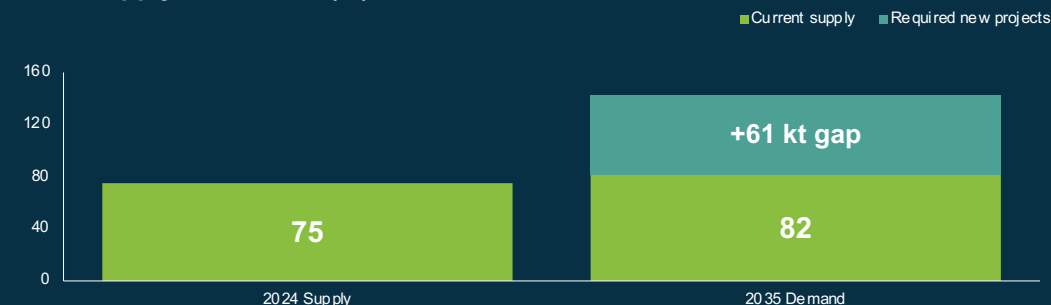
Robotics + defence

Morgan Stanley sees 600M humanoid robots by 2040 needing 1.7Mt of REE magnets (480x 2025); 418kg of rare earths per F-35 - Western OEMs and governments buying upstream now.

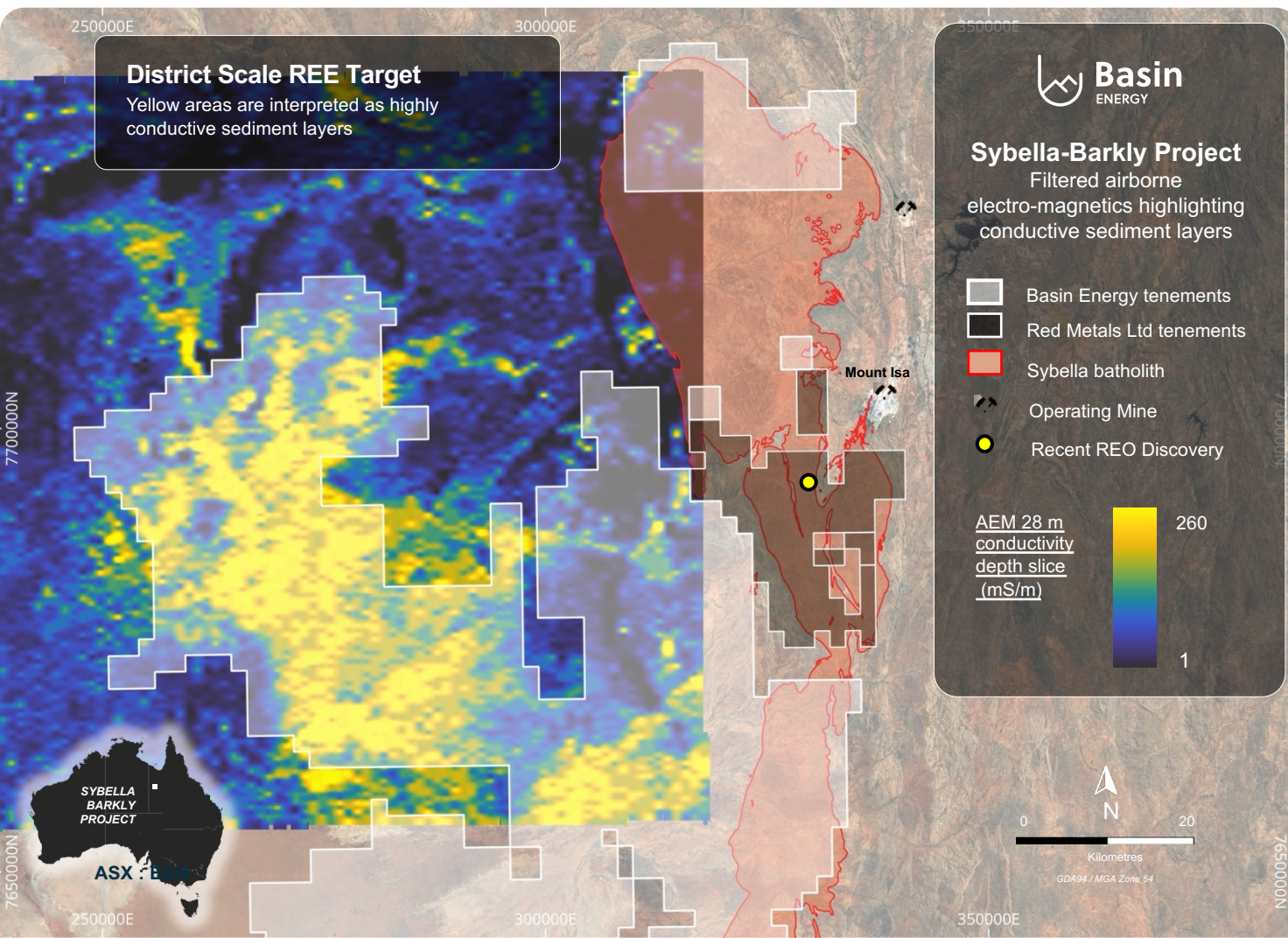

Present-day seasonal creeks and paleo-drainages both run westwards from the Sybella

Classic setup for sediment-hosted U transport

Historical drilling (for base metals and phosphate) intersected first-order rollfront indicators

redox fronts, impermeable caprocks, sandstone channels

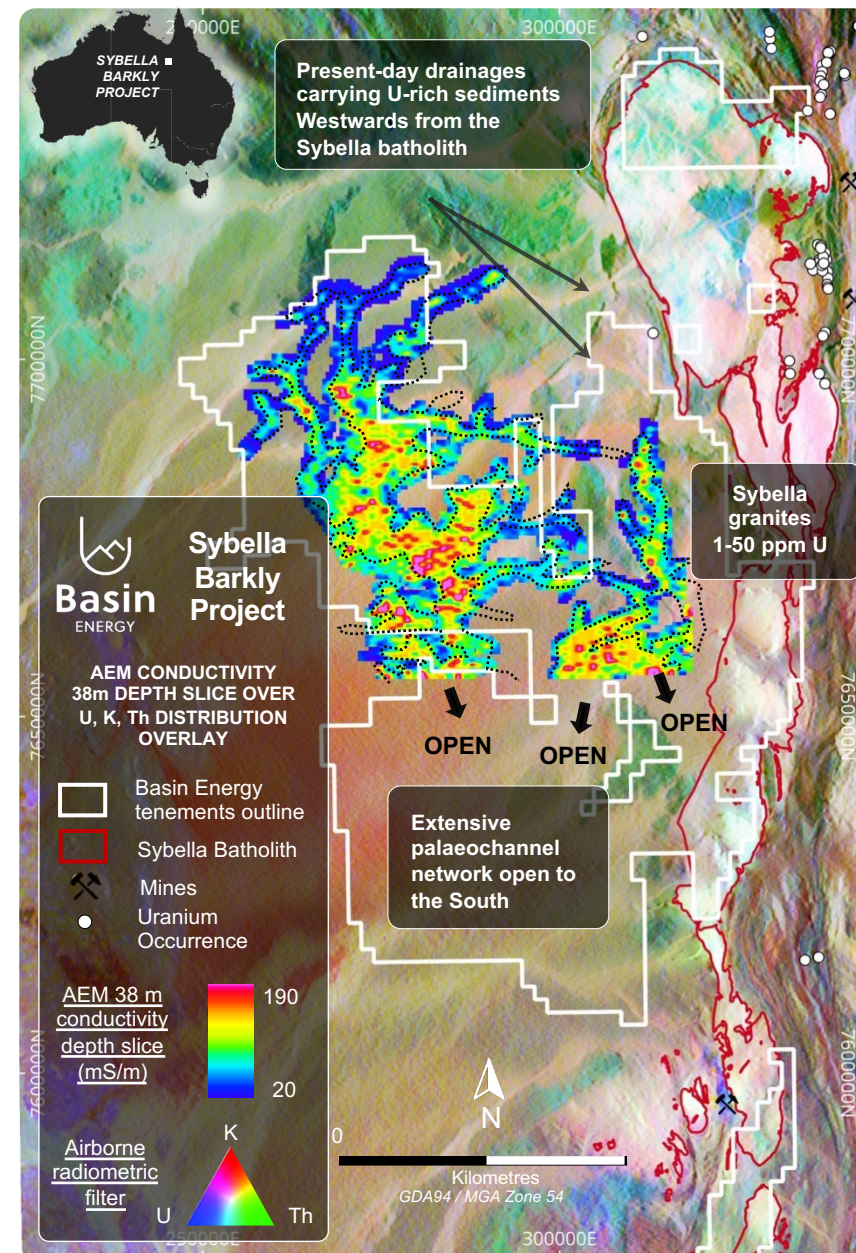
Critically: none of those historical holes were assayed for uranium

2025 Scout drilling

Scout drilling has also defined a coherent multi-kilometre palaeochannel system prospective for roll-front uranium, with uranium anomalism of up to 35 ppm U_3O_8 intersected within oxidised channel sediments

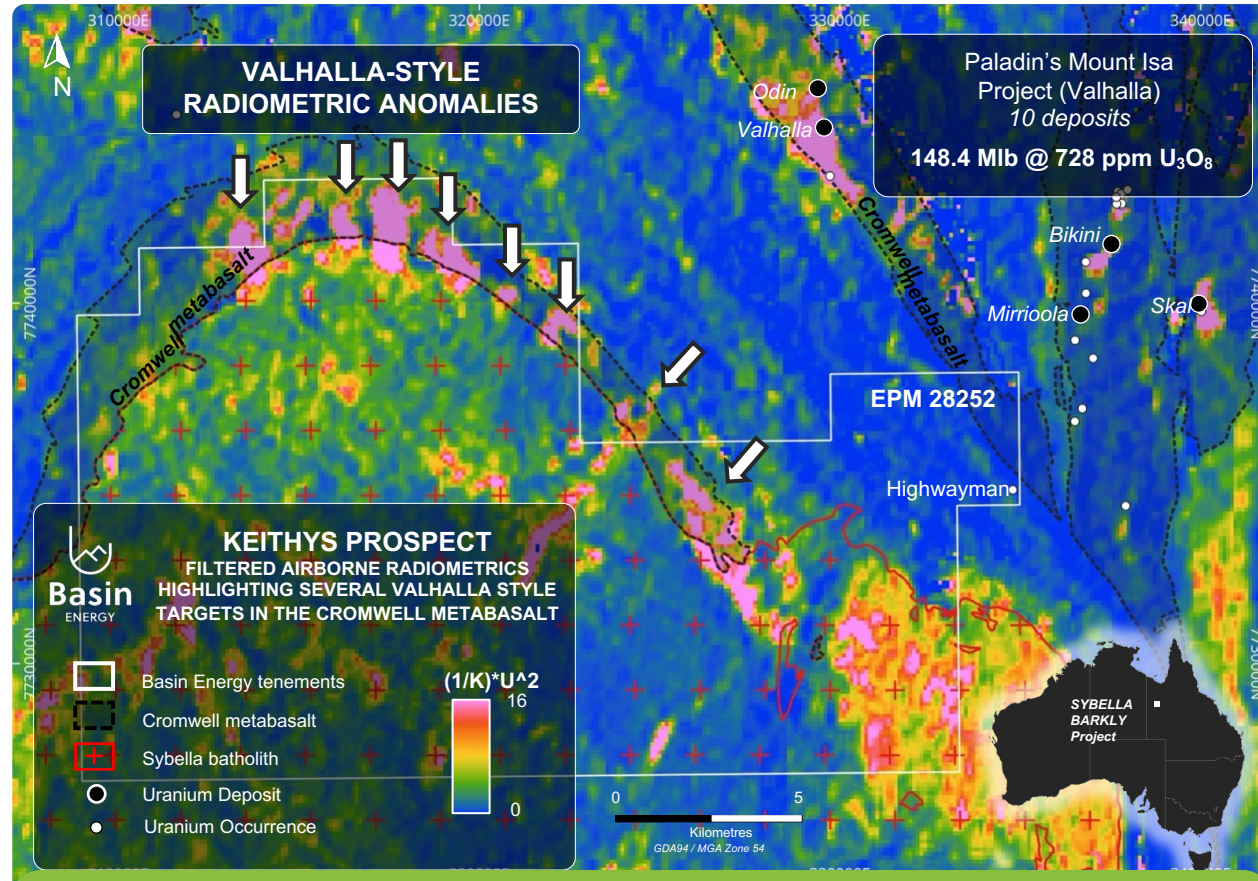
Next stage targeting refinement

via the CEI-funded airborne EM survey planned Q3 2026 - covers this southern corridor jointly with target 2 (sediment REE)
