NOTIFICATION OF EXPIRY OF OPTIONS

Dear Option Holder

At the close of business on 10 October 2025, you were a registered holder of Clever Culture Systems Limited ("CC5" or the "Company") listed options (ASX: CC5OA) ("Options"). You may have received these Options as a participant in the rights issue (refer ASX Announcement 15 November 2023) or the placement of the rights issue shortfall, or you may have subsequently purchased the Options on market.

This letter notifies you of the impending expiry of the listed Options at 5.00pm (Adelaide time) on 15 November 2025. It also sets out your alternative courses of action prior to expiry and provides information about recent market prices of the Company's Shares.

Each Option is exercisable into one fully paid ordinary share in the Company upon payment of the exercise price of \$0.008 per Option prior to the expiry date of 15 November 2025.

As a holder of the Options you have three choices available to you:

1. Exercise all or a portion of your Options

To exercise your Options your cleared funds must be received by the Company by no later than 5.00pm (Adelaide time) on Saturday 15 November 2025. An Option Expiry Notice is attached, however you may request a replacement notice and payment details from the Company +61 8 8227 1555 during office hours.

2. Sell all or a portion of your Options on market

If you do not wish to exercise your Options, you may wish to consider selling your Options on the ASX. Your Options are currently trading on the ASX under the ASX code: CC5OA. The Options will cease trading at the close of trading on the ASX on Monday 10 November 2025.

3. Do nothing and allow your Options to lapse

If you do not take any action per alternatives one and two above, the Options will expire and your right to purchase shares at \$0.008 will lapse.

In accordance with the ASX Listing Rules the Company advises the following:

- The number of Options you held at the close of business on 10 October 2025 is set out above.
- Each Option entitles the holder to, on exercise, one fully paid ordinary share in the Company. If all current Options are exercised, 259,775,158 fully paid ordinary shares would be issued.
- The exercise price of the Options is \$0.008 per Option.
- The due date for payment of the exercise price is 5.00pm (Adelaide time) Saturday 15 November 2025.
- If cleared funds are not received by 5pm (Adelaide time) on Saturday 15 November 2025 then your Options will expire with no value and no further entitlement will exist.

- Official quotation of the Company's Options on the ASX will cease at the close of trading on Monday 10 November 2025.
- There is no underwriting agreement in place for the exercise of the Options.
- The market price of the Company's shares on the last practicable date prior to finalising of this notice was \$0.034 at the close of trading on 10 October 2025.
