Share Purchase Plan Closing

CONNEQT Health Limited (ASX: CQT) (“CONNEQT” or “the Company”) would like to remind interested eligible shareholders that, unless extended, the Share Purchase Plan (SPP) announced on 19 June 2026 will **close at 5:00pm (Sydney time) on Friday, 31 July 2026**, monies are due by this time.

The SPP provides eligible shareholders the opportunity to acquire new CONNEQT shares at the same price of \$0.022 per share as the Company’s recent placement (refer to ASX announcement dated 19 June 2026).

Since announcing the SPP, the Company has released its June 2026 Quarterly Activities Report which highlighted continued commercial progress across the business, including record quarterly consumer revenue, continued expansion of the Enterprise business and advancement of the SphygmoCor Cloud regulatory programme. The Company remains focused on executing its commercial growth strategy, with the funds raised under the offer to support inventory, enterprise expansion, product development and working capital, as outlined in the SPP booklet.
