(ii) Everest Metals Corporation Ltd (EMC) and its wholly owned subsidiary Oz Gold Group Pty Ltd have entered into a fully integrated Right to Mine Agreement (RTMA) and Specific Security Deed (SSD) with Bain Global Resources (Bain) and its wholly owned mining services subsidiary MEGA Resources (MEGA). Under the RTMA, Bain is providing up to \$18.6M in financing for Mt Dimer development working capital. This funding is at Bain's sole risk, at nil interest and is recoverable only from project revenues. The committed working capital and development expenditure is secured by the SSD with recourse only to the ore stockpiles. EMC and Bain equally share the profits (50/50) from the Mt Dimer mine plan. Refer to ASX announcement dated 28 October 2025. The \$18.6M Bain finance facility is not considered as available to EMC as all drawings from the facility are to be jointly approved by both EMC and Bain. Draw downs on the Bain finance facility will not be incorporated into EMC's cashflows, other than the amounts distributed from the jointly controlled Bain/EMC bank account to EMC's solely controlled bank account/s.
