Section 708A Cleansing Notice

This notice is given by EQ Resources Limited (**EQR** or the **Company**) under Section 708A(5)(e) of the Corporations Act 2001 (Cth) (**Corporations Act**).

The Company hereby confirms that:

- (a) On 7 August 2026 it issued 4,431,807 fully paid ordinary shares (Shares), 2,415,667 from the exercise of options at an issue price of \$0.0675 (6.75 cents) and 2,016,140 from the cashless exercise of options issued to employee under the Company's Employee Incentive Plan;
- (b) the Shares were issued without disclosure to investors under Part 6D.2 of the Corporations Act;
- (c) the Company is providing this notice under paragraph 5(e) of section 708A of the Corporations Act
- (d) as at the date of this notice the Company has complied with:
 - i. the provisions of Chapter 2M of the Corporations Act as they apply to the Company;
 - ii. and sections 674 and 674A of the Corporations Act; and
- (e) as at the date of this notice, there is no excluded information of the type referred to in Sections 708A(7) and 708A(8) of the Corporations Act which is required to be disclosed pursuant to section 708A(6)(e).

As previously disclosed, EQR is exploring strategies to acquire access to further tenements surrounding the Company's mining operations in North Queensland. To that end, a number of discussions have been held with third parties. Apart from those already disclosed to the market, no further binding or definitive agreement has been reached and there is no guarantee that any further transaction will proceed. EQR will make an immediate announcement to the market if a definitive agreement is reached.
