

Voluntary Lodgement of Appendix 4C and Update

Sydney, 17 October 2025

We attach the Fiducian Group Limited's (ASX: FID) Appendix 4C for quarter ending 30 September 2025.

The lodgement of the Appendix 4C at the end of the first and third quarters of a financial year is a voluntary act undertaken by the company and is not required by the ASX.

In conjunction with the Appendix 4C, we also announce that:

- (a) net inflow to the core Fiducian platform for the quarter ending 30 September 2025 was \$102 million (quarter ending September 2024: \$101 million net inflow);
- (b) At 30 September 2025, badged platform and Auxilium fund balance was \$256 million and the net inflow for the quarter ending 30 September 2025 was \$5 million (\$22 million net inflow in the quarter ending September 2024). The net outflows from legacy IFAs for the quarter ending 30 September 2025 was \$25 million (quarter ending September 2024: \$13 million net outflow); and
- (c) Funds Under Management, Administration and Advice as at 30 September 2025 was \$15.6 billion (September 2024: \$14.2 billion).
