Highlights :

- Cue Project (Murchison region, WA) — Golden Dragon's primary focus is the Cue Project, located near the historic Cue gold camp in the Murchison goldfields. The Company has identified multiple gold targets along prospective shear zones and is focusing early exploration activities on systematic drilling and target testing.
- The Cue Project area covers over 600km² and sits within a prolific Tier-1 gold-producing province with nearby production:
 - West Gold's Tuckabianna
 - West Gold's Bluebird
 - Ramelius' Dalgaranga
 - Ramelius' Mt Magnet
- Exploration and growth strategy — Golden Dragon's exploration team will commence immediately exploring high-priority targets for drilling and evaluation. Multiple high-grade targets existing in Stockyard, Curtis Find and Coodardy prospects
- Chairman Rhod Grivas and Managing Director, Simon Buswell mobilised to site this week at the Cue Project, completing reconnaissance exploration and locating the inaugural drillholes at Coodardy and Curtis Find targets.
