Correction – Shareholder Distribution Schedule (Listing Rule 4.10.7)

Great Dirt Resources Ltd (ASX:GR8) ("the Company" or "Great Dirt") refers to its announcement titled "Annual Report to Shareholders" released to ASX **last calendar year on 21 August 2025**.

ASX has advised the Company that the shareholder distribution schedule disclosed in the Annual Report for the financial year ended 30 June 2025 did not include disclosure of a distribution schedule correctly for all equity securities on issue at the date of the report required under Listing Rule 4.10.7 (ordinary shares under escrow and unquoted options were omitted completely and percentages were omitted for ordinary shares).

Included at Annexure A to this announcement, the aforementioned information has been included.

The Company confirms that this announcement is lodged to correct the omissions made and additionally that it has reviewed its annual reporting processes and controls and has implemented additional verification procedures to ensure ongoing compliance with ASX Listing Rule disclosure requirements and to prevent a recurrence of this issue.

This correction does not affect the Company's financial statements or any other disclosures contained in the 30 June 2025 Annual Report.
