Results of Annual General Meeting

HyTerra Ltd (**ASX: HYT**) (**HyTerra** or the **Company**) advise the results of the Annual General Meeting (**AGM**) held today. All resolutions were determined on a poll. The voting outcomes are set out in the attachment to this announcement. As is noted in the attached, most of the resolutions put to Shareholders at the meeting were not carried.

Shareholders will note from the attached voting details that the outcome of the poll for Resolution 2, which was ultimately passed by shareholders, differed from the proxy positions lodged ahead of the AGM. This reflects votes cast in person at the meeting by, or on behalf of, a Shareholder whose representative attended the meeting and voted differently from the proxy lodged before the proxy cut-off. This is a recognised feature of the proxy and corporate representative provisions of the *Corporations Act 2001* (Cth) and the Company's Constitution.

The Company notes the result on Resolution 1 (Remuneration Report) constitutes a "first strike" for the purposes of section 250U of the *Corporations Act 2001* (Cth). As the Company did not receive a "first strike" at its 2025 Annual General Meeting, no "Spill Resolution" arises in respect of this Meeting.

The Board will consider the outcomes of the AGM and engage with key stakeholders to better understand concerns regarding the reasons for the voting outcomes and will consider the implications for the Company's remuneration framework and governance arrangements. The Board will provide further updates to the market as required by its continuous disclosure obligations.

The outcome of voting and details of the aggregate number of securities for which valid proxies were received before the meeting in respect of each resolution are attached in accordance with the requirements of ASX Listing Rule 3.13.2 and section 251AA(2) of the *Corporations Act 2001*.
