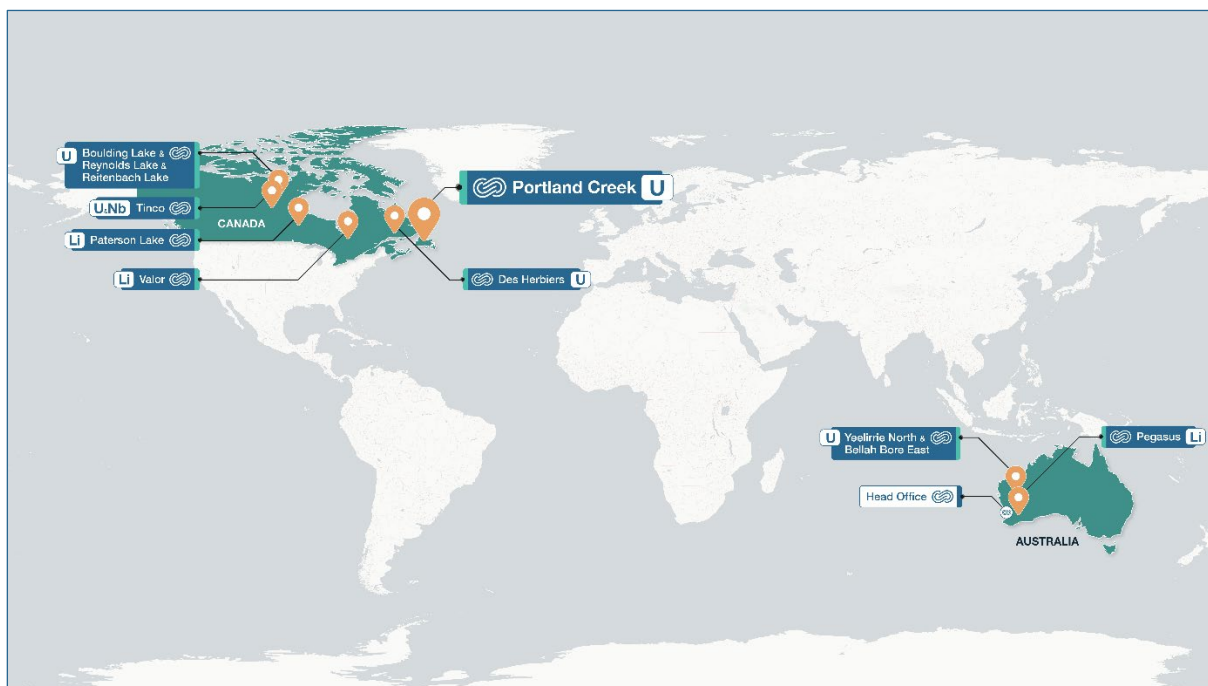


Figure 1: Overview of Infini's portfolio of projects and global footprint.
