Chairman's Report

The share market continued to advance over 2026 but at a more constrained pace due to three RBA interest rate hikes and Federal budget changes to capital gains tax and negative gearing. These factors were negative for the banking sector from its exposure to residential mortgages, but a strong resources sector provided good gains for investors. The increase in the RBA cash rate to a more restrictive stance was in response to building inflation pressures from the Iran war that lifted the oil price on top of existing domestic inflation pressures.

The AI theme dominated US stock market performance and the build out of AI data centers is commodity intensive, which contributed to higher commodity prices, particularly copper that benefited our large diversified resource companies. However, long term sovereign bond markets performed poorly driven by higher US bond yields in response to growing US budget deficit pressures, higher oil prices, and competition from the massive supply of AI infrastructure debt.

The Ironbark portfolio was well positioned with floating rate bonds and hybrids together with a resource bias in its buy and write portfolio.

Results for the Financial Year & Final Dividend

The net profit after tax of \$2.89 million compared to \$3.07 million achieved in the previous corresponding year. The reduction was due to higher income tax expense. Total investment income increased to \$4.23m from \$4.10m in the previous year. NTA per share increased over the year from investment gains and a reduction in issued shares from the on market buy back.

NTA per share after provision for tax on unrealised gains was \$0.578. The NTA return after tax was 6.1% over the year including fully franked dividends of 2.6 cents per share, or 7.7% return grossed up for franking credits.

The total shareholder return for the financial year, inclusive of franking credits, was 5.1%. The share price discount to the post tax NTA was 26.6% as at 30 June 2026.

Since the end of the financial year, the Directors have declared a fully franked dividend of 0.6 cents per share for the quarter ended 30 June 2026 to be paid on 25 September 2026. Fully franked dividends for the 2026 financial year were 2.5 cents unchanged from 2.5 cents per share in the previous year. The dividend rate represented a yield of 5.9% or 7.8% grossed up for franking credits based on the 30 June 2026 share price of 42.5c.

Investment Performance

For the year ended 30 June 2026, the Ironbark portfolio returned 7.8% inclusive of franking credits, outperforming the Benchmark (RBA cash + 3%p.a.) by 0.95%. The sound performance was achieved with around a third of the volatility/risk of the equities market reflecting the diversified balance of investments.

Ironbark's performance reflects the Investment Manager's absolute return focus and income emphasis including the writing of call options. The Investment Manager's report by Kaplan Funds Management (KFM), which follows the Chairman's Report, sets out in detail the investment experience in this 2026 financial year.

Capital Management

The on-market share buy-back for up to 10% of the Company's shares over 12 months continued in the 2026 financial year and 4,236,585 shares were bought back in the period to 30 June 2026.

The buy-back of shares at a discount to NTA increases the NTA for the benefit of all shareholders.

In accordance with the Company's capital management program, the program has been extended for a further 12 months until 19 July 2027. This provides the mechanism for the Company to buy back its shares during prolonged periods of share price volatility when there is a significant discount to underlying NTA.

The Year Ahead

The year ahead will continue to provide challenging times for financial markets, emanating from geopolitical events, persistent inflation pressures, tax changes and the impact of AI.

The Ironbark portfolio with its conservative settings is well positioned in this environment to deliver fully franked dividends and satisfactory returns within an acceptable risk profile.

Investment Manager Report – financial year to 30 June 2026

The manager's objective is to deliver consistent returns from a diversified portfolio with an income emphasis. IBC seeks to pay a high fully franked dividend yield from the portfolio. IBC's performance benchmark is RBA cash rate plus 3% per annum.

Performance measurement includes franking credits and option premium income. Franking credits are included in performance because they are a significant source of return from IBC's hybrid investments and are beneficial for shareholders. Option premium income is generated from buy & write activity and varies with market conditions. Over the year, realised option premium income was around \$0.17m (0.3% of the portfolio). The calculation of the portfolio's current running yield of 6.4% excludes option income because realised option premiums are highly variable from year to year.

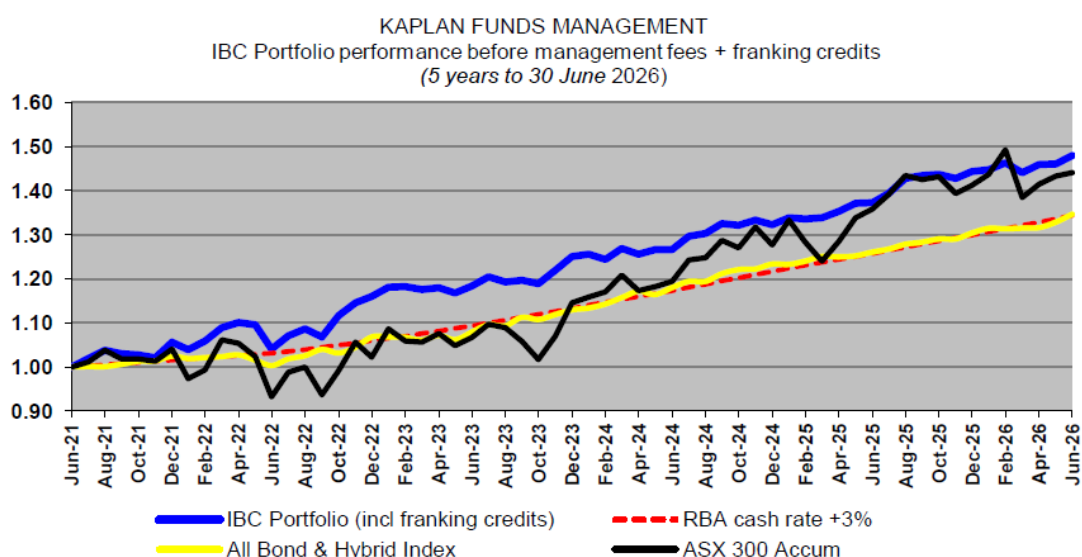
IBC recorded a sound return of 7.80% over the 2026 financial year with conservative settings. The return was achieved with low volatility measuring 36% of the ASX Index volatility.

Since inception, over 24 years the portfolio delivered a return of 8.8%pa with approximately half of the ASX Index risk, measured in terms of volatility. IBC's focus on income generation and capital preservation from a balanced portfolio structure has delivered very good risk adjusted returns compared to the equities market.

Portfolio

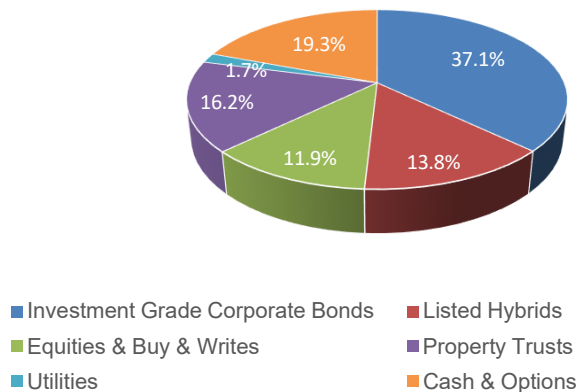
The portfolio is structured with an emphasis on income through yield orientated securities (hybrids and corporate bonds, utilities, property trusts) and buy & write positions in leading companies. The portfolio's running yield was 6.4% inclusive of franking credits but excluding option premium income.

The buy & write strategy involves buying selective shares and selling, subject to appropriate timing, call options over those shares. This strategy gives away some of the upside potential from a shareholding but generates option premium income consistent with the income emphasis of the portfolio.

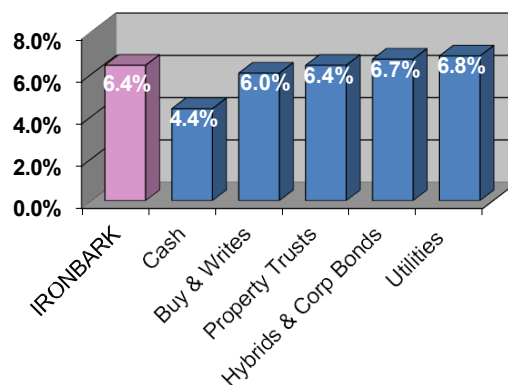
The portfolio is diversified across 25 different entities. Higher risk exposures in banks, industrials and resources are largely held through buy & write option positions for income enhancement or added protection. The portfolio's hybrid and corporate bond holdings are mostly floating rate securities with little duration risk.

Approximately 51% of the portfolio was held in hybrids and corporate bonds, 12% in buy & write and equity exposures across industrials and resources, 16% in property trusts, 1.7% utilities, and 19% held in cash & option delta.

(inclusive of franking credits)



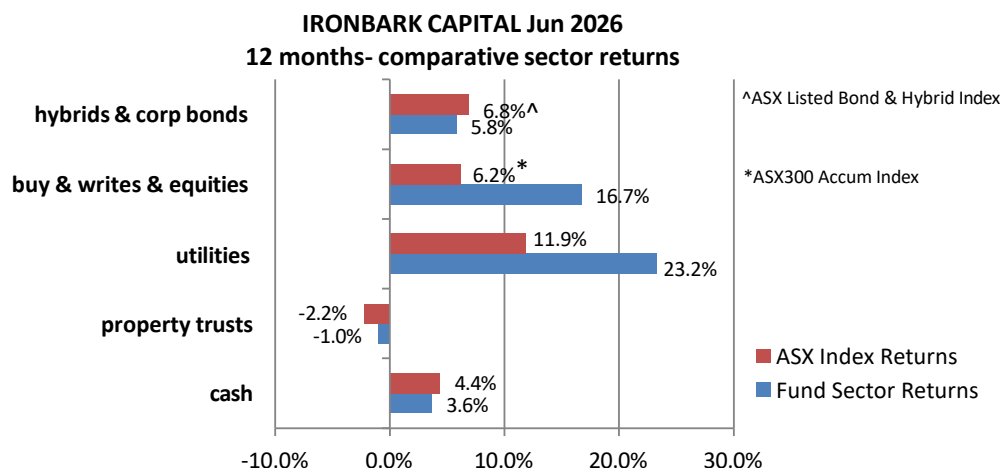
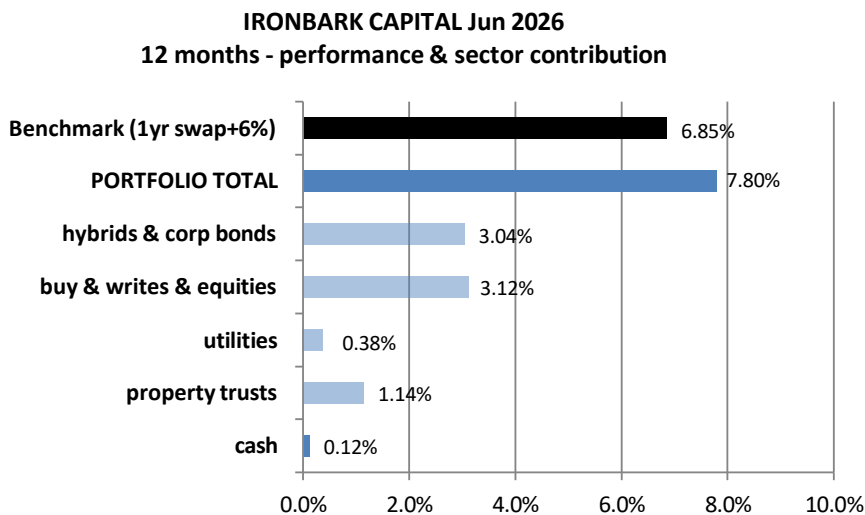
Portfolio Performance-financial year to 30 June 2026

The portfolio recorded a return of 7.80% for the financial year.

Hybrid and corporate bonds delivered a sound return of 5.8% over the year. The portfolio increased unlisted corporate subordinate notes and reduced bank hybrids that were redeemed at par. The phasing out the listed bank hybrid market by 2032 has resulted in redemption certainty providing positive support for ASX bank hybrids.

Buy & writes returned 16.7% and benefited from strong resource shares and good gains by ANZ and WBC. CBA fell -8.2% not held by the portfolio. Call option writing detracted from gains by capping upside participation in strongly performing shares.

Property trust holdings returned -1.0% negatively impacted by three RBA cash rate hikes over the last six months. Utilities performed well up 23% with the addition of APA Group to the portfolio

Directors' Report

The Directors present their report on the Company for the year ended 30 June 2026.

Directors

The following persons were Directors of Ironbark Balanced Income Limited during the financial year and up to the date of this report:

Directors have been in office since the start of the financial year to the date of this report unless otherwise stated.

Principal activities

The principal activity of the Company is the investment in securities listed on the Australian Securities Exchange. The primary focus emanating from this activity is the payment of fully franked dividends and the preservation of capital.

Review of Operations

The profit from ordinary activities after income tax amounted to \$2.89 million (2025: \$3.07 million).

Investment revenue increased to \$4.20 million from \$4.10 million in the previous corresponding year. The improvement was primarily driven by unrealised gains on investments of \$1.95 million, compared with unrealised losses of \$1.35 million in the previous year. Dividend income, however, decreased by 18%, reflecting, in part, lower dividend payout ratios.

A key component of the Company's result is the change in the fair value of the underlying investment portfolio, which can result in fluctuations in profit from year to year. During the current financial year, the Company recorded unrealised gains on investments of \$1.96 million, compared with unrealised losses of \$1.35 million in the previous year, reflecting the improved performance of the investment portfolio. This positive movement was partially offset by lower realised gains on investments, with the Company recording a realised loss of \$0.82 million, compared with realised gains of \$1.99 million in the previous year. In addition, dividend income declined by 18%, reflecting lower dividend payout ratios, while trust distribution income increased by 7% over the prior year.

NTA per share after provision for tax on unrealised gains was \$0.578, up 2.28% compared to the previous period. The NTA is after payment of fully franked dividends of 2.6 cents per share.

The on-market share buy-back for up to 10% of the Company's shares over 12 months continued in the 2026 financial year and 4,236,585 shares were bought back in the period to 30 June 2026.

In accordance with the Company's capital management program, the program has been extended for a further 12 months until 19 July 2027. This provides the mechanism for the Company to buy back its shares during prolonged periods of share price volatility when there is a significant discount to underlying NTA.

Dividends declared and paid

Subsequent to year end, the Directors declared a final fully franked dividend of 0.60 cents per share with record date of 4 September 2026 and payable on 25 September 2026. In addition, the March 2026 quarter dividend 0.6 cents per share, with record date of 15 May 2026, was paid 02 July 2026.

The Company has an Investment Management Agreement and an Administrative Agreement with Kaplan Funds Management Pty Ltd, the Investment Manager, such that it will manage investments of the Company, ensure regulatory compliance with all the relevant laws and regulations, and provide administrative and other services for a fee. Sam Kaplan is Managing Director of Kaplan Funds Management Pty Limited.

An entity associated with Sam Kaplan, Kaplan Partners Pty Limited, holds 100% of the shares of Kaplan Funds Management Pty Limited.

For the year ended 30 June 2026 the management fee (net of RITC) was \$364,092 (2025: \$369,748). The administrative fee for accounting and secretarial services (net of RITC) was \$83,409 (2025: \$81,394).

1. General information

Ironbark Balanced Income Limited (the "Company") is a listed public company domiciled in Australia. The address of Ironbark Balanced Income Limited's registered office is Level 8, 210 George Street, Sydney, NSW 2000. The financial statements of Ironbark Balanced Income Limited are for the year ended 30 June 2026. The Company is primarily involved in making investments and deriving revenue and investment income from listed securities, wholesale fixed interest securities and unit trusts in Australia.

2. Significant accounting policies

The principal accounting policies adopted in the preparation of these financial statements are set out below. These policies have been consistently applied to all the years presented, unless otherwise stated. The financial statements are for the entity Ironbark Balanced Income Limited.

(a) Basis of preparation

These general purpose financial statements have been prepared in accordance with Australian Accounting Standards and interpretations issued by the Australian Accounting Standards Board and the *Corporations Act 2001*. The Company is a 'for profit' entity.

The Financial Statements were authorised for issue by the directors on 19 August 2026.

(i) Compliance with IFRS

Australian Accounting Standards include Australian equivalents to International Financial Reporting Standards (AIFRS). AIFRS ensures that the financial statements and notes comply with International Financial Reporting Standards (IFRS).

(ii) New and amended standards adopted by the Company

The following amendments to the accounting standards became applicable from 1 January 2026, but do not have an impact on the Financial Statements of the Company:

AASB 2020-1: Amendments to Australian Accounting Standards – Classification of Liabilities as Current or Non-current.

AASB 2020-1 amends AASB 101 to clarify the requirements for presenting liabilities as current or non-current in the statement of financial position, including the meaning of "settlement of a liability".

AASB 2022-6: Amendments to Australian Accounting Standards – Non-Current Liabilities with Covenants.

The Company adopted AASB 2022-6, which amends AASB 101 to clarify disclosures about liabilities arising from loan arrangements where the right to defer settlement for at least 12 months after the reporting period depends on compliance with specified covenants.

(iii) Historical cost convention

These Financial Statements have been prepared under the accruals basis and are based on historical cost convention, except that financial instruments are stated at their fair value through profit or loss.

2. Significant accounting policies (continued)

(iv) *Critical accounting estimates*

The preparation of financial statements requires the use of certain critical accounting estimates. It also requires management to exercise its judgment in the process of applying the Company's accounting policies. The areas involving a higher degree of judgment or complexity, or areas where assumptions and estimates are significant to the financial statements, refer to Note 4.

(b) **Revenue recognition**

Revenue is measured at the fair value of the consideration received or receivable. Amounts disclosed as revenue are net of returns and trade allowances.

(i) *Trading income*

Profits and losses realised from the sale of investments and unrealised gains and losses on securities held at fair value are included in the Statement of Profit or Loss and Other Comprehensive Income in the year they are earned/incurred.

(ii) *Dividends and trust distributions*

Dividends and trust distributions are recognised as revenue when the right to receive payment is established.

(iii) *Interest income*

Interest income is recognised using the effective interest method.

(iv) *Other income*

The Company recognises other income when the amount of revenue can be reliably measured, it is probable that future economic benefits will flow to the entity and specific criteria have been met for each of the Company's activities as described above.

(c) **Income tax**

The income tax expense (or tax benefit) for the period is the tax payable on the current period's taxable income based on the applicable income tax rate adjusted by changes in deferred tax assets and liabilities attributable to temporary differences and to unused tax losses.

The current income tax charge is calculated on the basis of the tax laws enacted or substantially enacted at the end of the reporting period. Management periodically evaluates positions taken in tax returns with respect to situations in which applicable tax regulation is subject to interpretation. It establishes provisions where appropriate on the basis of amounts expected to be paid to the tax authorities.

Deferred income tax is provided in full, using the liability method, on temporary differences arising between the tax bases of assets and liabilities and their carrying amounts in the Financial Statements. Deferred income tax is determined using tax rates that have been enacted or substantially enacted by the end of the reporting period and are expected to apply when the related deferred income tax asset is realised or the deferred income tax liability is settled.

Deferred tax assets are recognised for deductible temporary differences and unused tax losses only if it is probable that future taxable amounts will be available to utilise those temporary differences and losses.

2. Significant accounting policies (continued)

(c) Income Tax (continued)

Deferred tax assets and liabilities are offset when there is a legally enforceable right to offset current tax assets and liabilities and when the deferred tax balances relate to the same taxation authority. Current tax assets and tax liabilities are offset where the entity has a legally enforceable right to offset and intends either to settle on a net basis, or to realise the asset and settle the liability simultaneously.

Current and deferred tax is recognised in profit or loss in the Statement of Profit or Loss and Other Comprehensive Income, except to the extent that it relates to items recognised in other comprehensive income or directly in equity. In this case, the tax is also recognised in other comprehensive income or directly in equity, respectively.

(d) Cash and cash equivalents

For the purpose of presentation in the Statement of Cash Flows, cash and cash equivalents includes cash on hand, deposits held at call with financial institutions, other short-term, highly liquid investments with original maturities of three months or less that are readily convertible to known amounts of cash and which are subject to an insignificant risk of changes in value.

(e) Trade and other receivables

Trade and other receivables are recognised initially at fair value and subsequently measured at amortised cost using the effective interest method, less provision for impairment. Trade and other receivables are generally due for settlement within 30 days. They are presented as current assets unless collection is not expected for more than 12 months after the reporting date.

Collectability of trade and other receivables is reviewed on an ongoing basis. Debts which are known to be uncollectible are written off by reducing the carrying amount directly.

(f) Trading portfolio

Classification

The trading portfolio comprises securities held for short term trading purposes, including exchange traded option contracts that are entered into, as described below. The purchase and the sale of securities are accounted for at the date of trade. Trade date accounting is adopted for financial assets that are delivered within timeframes established by market place convention.

Options are initially brought to account at the amount received upfront for entering the contract (the premium) and subsequently revalued to current market value. Increments and decrements are taken through the Statement of Profit or Loss and Other Comprehensive Income.

Securities in the trading portfolio are classified as "assets measured at fair value through profit or loss".

Recognition and derecognition

Purchases and sales of financial assets are recognised on trade date - the date on which the Company commits to purchase or sell the asset. Financial assets are derecognised when the right to receive cash flows from the financial assets have expired or have been transferred and the Company has transferred substantially all the risks and rewards of ownership.

Measurement

At initial recognition, the Company measures a financial asset or financial liability at its fair value. Transaction costs of financial assets carried at fair value through profit or loss are expensed in profit or loss.

Subsequent to initial recognition, the financial instruments are measured at fair value with changes in their fair value recognised in the Statement of Profit or Loss and Other Comprehensive Income.

2. Significant accounting policies (continued)

(f) Trading Portfolio (continued)

When disposal of an investment occurs, the cumulative gain or loss is recognised as realised gains and losses on trading portfolio in the Statement of Profit or Loss and Other Comprehensive Income.

The objective of determining fair value for a financial instrument that is traded in an active market is to arrive at the price at which a transaction would occur at the end of the reporting period. The existence of published price quotations in an active market is the best evidence of fair value and is used to measure the financial asset or financial liability.

Financial assets are valued at their fair value without any deduction for transaction costs that may be incurred on sale or other disposal. Certain costs in acquiring investments, such as brokerage and stamp duty are expensed in the Statement of Profit or Loss and Other Comprehensive Income.

(g) Derivatives

The Company may invest in financial derivatives. Derivative financial instruments are accounted for on the same basis as the underlying investment exposure. Gains and losses relating to derivatives are included in investment income as part of realised or unrealised gains and losses on investments.

(h) Trade and other payables

Trade and other payables represent liabilities for goods and services provided to the Company prior to the end of financial year that remain unpaid. The amounts are unsecured and are usually paid within 30 days of recognition. Trade and other payables are presented as current liabilities unless payment is not due within 12 months from the reporting date. They are recognised initially at their fair value and subsequently measured at amortised cost using the effective interest method.

(i) Issued capital

Ordinary shares are classified as equity. Incremental costs directly attributable to the issue of new shares or options are shown in equity as a deduction, net of tax, from the proceeds.

(j) Profit reserve

The Profit Reserve is made up of amounts transferred from current and retained earnings that are preserved for future dividend payments.

(k) Dividends

In accordance with the *Corporations Act 2001*, the Company may pay a dividend where the Company's assets exceed its liabilities, the payment of the dividend is fair and reasonable to the Company's shareholders as a whole and the payment of the dividend does not materially prejudice the Company's ability to pay its creditors.

It is the Directors' policy to only pay fully franked dividends and to distribute the majority of franking credits received each year. Franking credits are generated by receiving fully franked dividends from shares held in the Company's investment portfolio, and from the payment of corporate tax on its other investment income, namely share option premiums, unfranked income and net realised gains.

A provision for dividends payable is recognised in the reporting period in which dividends are declared, for the entire undistributed amount, regardless of the extent to which they will be paid in cash.

2. Significant accounting policies (continued)

(l) Earnings per share

(i) *Basic earnings per share*

Basic earnings per share is calculated by dividing:

- the profit attributable to owners of the Company, excluding any costs of servicing equity other than ordinary shares
- by the weighted average number of ordinary shares outstanding during the financial year, adjusted for bonus elements in ordinary shares issued during the year and excluding treasury shares.

(ii) *Diluted earnings per share*

Diluted earnings per share adjusts the figures used in the determination of basic earnings per share to take into account:

- the after income tax effect of interest and other financing costs associated with dilutive potential ordinary shares, and
- the weighted average number of additional ordinary shares that would have been outstanding assuming the conversion of all dilutive potential ordinary shares.

(m) Goods and Services Tax (GST)

Revenues, expenses and assets are recognised net of the amount of associated GST, unless the GST incurred is not recoverable from the Australian Taxation Office (ATO). In this case it is recognised as part of the cost of acquisition of the asset or as part of the expense.

Receivables and payables are stated inclusive of the amount of GST receivable or payable. The net amount of GST recoverable from, or payable to, the ATO is included with other receivables or payables in the Statement of Financial Position.

Cash flows are presented in the Statement of Cash Flows on a gross basis, except for the GST components of cash flows arising from investing or financing activities which are recoverable from, or payable to the ATO and are presented as operating cash flows.

(n) Rounding of amounts

The Company is of a kind referred to in Instrument 2016/191, issued by the Australian Securities and Investments Commission, relating to the 'rounding off' of amounts in the financial statements. Amounts in the financial statements have been rounded off in accordance with that Instrument to the nearest thousand dollars, or in certain cases, the nearest dollar.

(o) Functional and presentation currency

The functional and presentation currency of the Company is Australian dollars.

(p) Operating Segments

The Company operated in Australia only and the principal activity is investment.

2. Significant accounting policies (continued)

(q) New accounting standards for application in future periods

Certain new accounting standards and interpretations have been published that are not mandatory for 30 June 2026 reporting periods and have not yet been adopted in the financial statements. The directors' assessment of these new standards and interpretations are set out below:

AASB 2021-7c: Amendments to Australian Accounting Standards – Effective Date of Amendments to AASB 10 and AASB 128 and Editorial Corrections; and AASB 2025-4: Amendments to Australian Accounting Standards – Effective Date of Amendments to AASB 10 and AASB 128

AASB 2021-7c defers the application of AASB 2014-10 Amendments to Australian Accounting Standards – Sale or Contribution of Assets between an Investor and its Associate or Joint Venture so that the amendments are required to be applied for annual reporting periods beginning on or after 1 January 2026 instead of 1 January 2018. However, once AASB 2021-7c expires for periods beginning on or after 1 January 2026, AASB 2025-4 defers the mandatory effective date (of amendments to AASB 10 and AASB 128 that were originally made in AASB 2014-10) so that the amendments are required to be applied for annual reporting periods beginning on or after 1 January 2028 instead of 1 January 2025.

The Company plans on adopting the amendments to AASB 10 and AASB 128 within AASB 2021-7c for the reporting period ending 30 June 2026 and in line with AASB 2024-4 for the reporting period ending 30 June 2029. The impact of initial application is not yet expected to be material.

3. Financial risk management

The Company's activities expose it to a variety of financial risks: market risk (including interest rate risk and price risk), credit risk and liquidity risk. The Board of the Company has implemented a risk management framework to mitigate these risks.

(a) Market risk

The standard defines this as the risk that the fair value or future cash flows of a financial instrument will fluctuate because of changes in market prices.

(i) Price risk

The Company is exposed to equity securities price risk. This arises from investments held by the Company and classified in the Statement of Financial Position as trading portfolio.

The Company seeks to manage and constrain market risk by diversification of the investment portfolio across multiple stocks and industry sectors. The Investment Manager of the trading portfolio has been granted specific risk tolerance boundaries as set out in the Investment Management Agreement.

The Investment Manager monitors cash-flow requirements daily taking into account upcoming dividends, tax payments and investing activity.

The Company's inward cash flows depend upon the level of dividend and distribution revenue received. Should these decrease by a material amount, the Company would amend its outward cash flows accordingly. As the Company's major cash outflows are the purchase of securities and dividends paid to shareholders, the level of both of these is managed by the Board and Investment Manager. The assets of the Company are largely in the form of readily tradable securities which can be sold on-market if necessary.
