With more than 40 years' experience as a broker, investment banker and fund manager, US-based Mr Orrell is regarded as one of the most experienced gold fund portfolio managers in the global precious metals sector. He has been recognised by Lipper Refinitiv for top fund performance in the precious metals category across multiple time periods.

Mr Orrell brings deep expertise in gold markets, including a strong understanding of gold's monetary role in the global economy. He is a widely quoted commentator on precious metals and mining equities across national financial publications, podcasts and broadcast media. Mr Orrell holds a Bachelor of Science in Economics and Business Administration from Saint Mary's College, California.
