Update on Activities

Highlights for the Quarter

- Key Petroleum Limited (“Key” or “the Company”) remains focused on progressing its core interests in the Cooper-Eromanga Basin, Queensland. Following the submission of eight Potential Commercial Area (PCA) applications – four each over ATP 920 and ATP 924 – earlier this year, in early September, the Queensland Department of Resources (DNRME) system indicates that they are at the decision stage, which indicates that a decision is imminent.

The Company is very pleased with the current status of the PCA application and is hoping to receive formal government approval around the end of 2025. This would mean that the two permits will have a 15-year window, allowing the Company to effectively carry out development planning, attract more partners and funding, and realize the full value of the two PCAs. This, in turn, will elevate the Company’s operations and overall value to a new level. The Company plans to commence the relevant technical studies immediately after the PCA approval is confirmed, laying the groundwork for the subsequent development plan.

- In August, the Company successfully introduced two new major shareholders. Following the new share issuance, the two new shareholders hold 10.72% and 8.73% of the Company’s shares, respectively. The introduction of these new shareholders has injected a certain amount of operating capital into the Company and provided better opportunities for future development.
- During this quarter, the Company also made changes to the Board of Directors, primarily involving the replacement of the Managing Director. The new team has strengthened the support of professional and technical personnel compared with before, bringing greater vitality to the Company and enabling more efficient and professional operational management for the benefit of the Company.

Activities for the Upcoming Quarter

- Based on the current status of the two PCA applications, it is very likely that a formal decision will be made by the DNMRE in the near future. The Company will first consider arranging a meeting with the relevant government departments to explain the significant importance of the two PCAs to the Company, as well as the follow-up plans that will be implemented once the approvals are obtained. Once the PCAs are formally approved, the Company will immediately initiate professional technical studies and financing plans, and commence preliminary development work related to the PCA assets.
- The Company’s current financial position remains a priority for the Board of Directors as the Company looks for new opportunities for the future.
- Following the recent changes to the Company’s Board of Directors, a new development strategy is being formulated. While continuing to pursue opportunities in oil and gas projects, the Company should also appropriately consider the feasibility of business diversification. By analyzing the current situation of the mineral and energy sectors and assessing future trends, the Company aims to develop a practical, sustainable, and healthy long-term growth plan.

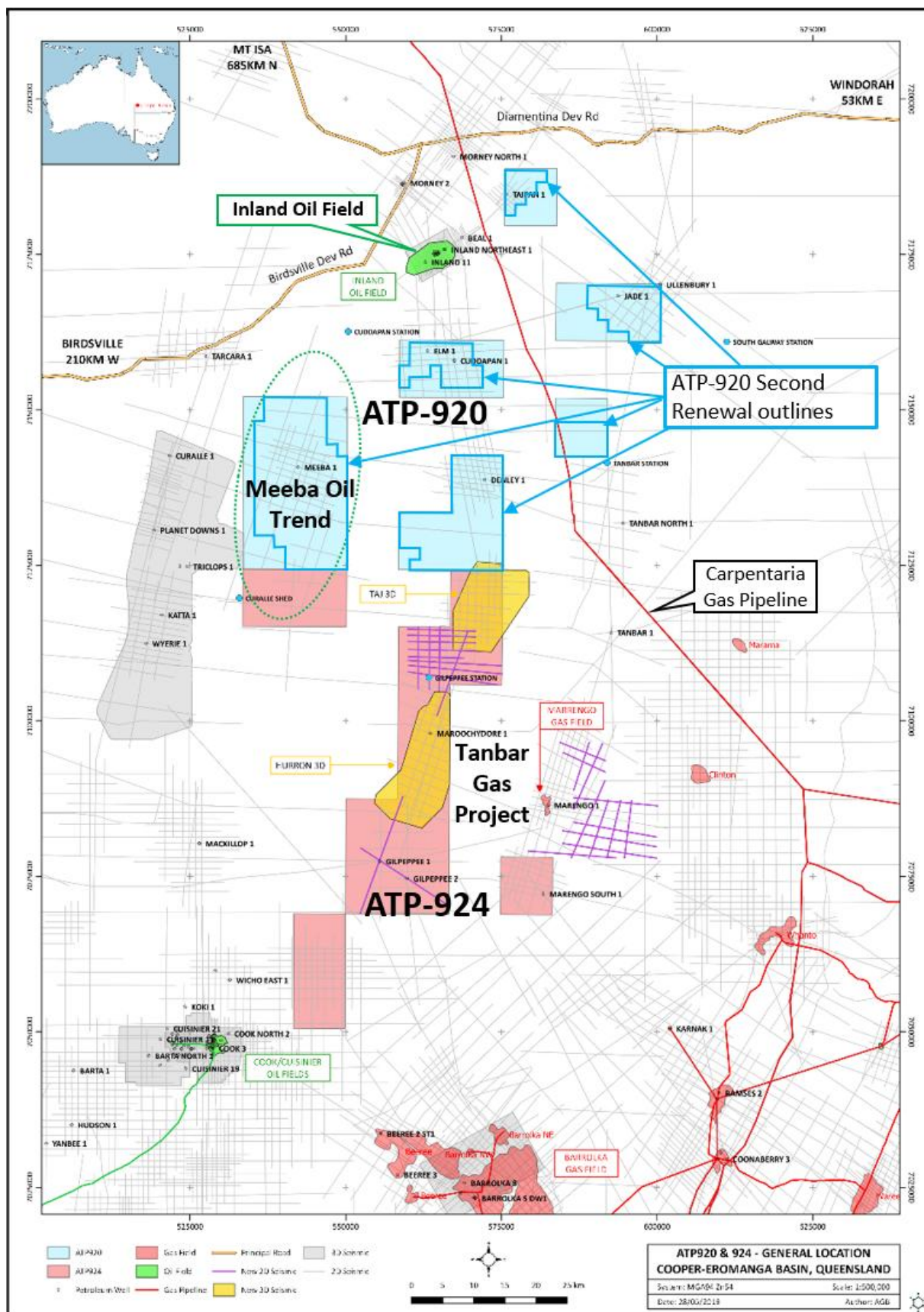


Figure 1: Impact of Lake Eyre Basin boundaries on ATPs 920 and 924.

Corporate and Current Outlook for Key

- As of the end of the September 2025 quarter, Key Petroleum Limited had A\$277,535 in cash on hand.

During the previous quarter, the Company completed a non-renounceable pro-rata entitlement offer, with a shortfall of 2,954,682 shares.

On 31 July 2025 the shortfall of 2,954,682 shares was placed to raise A\$183,190.

On 6 August 2025 the Company completed a placement of 3,627,636 shares to raise \$152,361.

- Key is confident in its ability to meet operational needs in the coming quarters and has the ability to pursue additional funding options as needed with the support of shareholders willing to step in and assist.
- During the quarter, the Company paid the amounts noted at Items 6.1 and 6.2 on the Appendix 5B, being payments of \$72,000 to related parties and their associates. This was the aggregate amount paid to the directors including directors' fees and consulting fees (\$42,000), and corporate administration and management fees (\$30,000).
- Total E&E expenditure for the quarter was \$3,000.
