Quotation of Options, Top 20 and Distribution Schedule

Koba Resources Limited (ASX:KOB) advises that it expects the quotation of 80,778,092 options exercisable at \$0.08 and expiring 30 June 2028 (**Quoted Options**), to commence on 7 August 2026.

The Quoted Options were originally issued as unlisted options on various dates between 16 June 2025 and 18 December 2025.

To facilitate trading in the Quoted Options, the Company lodged a cleansing prospectus (**Cleansing Prospectus**) with ASIC on 27 May 2026, which had a closing date of 31 August 2026. In accordance with the Corporations Act 2001 (Cth), the Cleansing Prospectus removes any on-sale restrictions that would otherwise apply to the Quoted Options.
