Answer:

On completion of the sale of non-core interest in Greater Duchess in October, the Company received \$2m cash consideration and unrestricted fully paid shares in Carnaby Resources Ltd to the value of \$4m. The Company has sold a proportion of these shares during the quarter providing additional cash reserves. At the quarter end, the Company held remaining of these unrestricted shares with market value of ~\$3.5m. The sale of shares subsequent to the quarter end will provide additional non-dilutive funds for the advancement of its Finnish and Western Australian assets.

8.8.3 Does the entity expect to be able to continue its operations and to meet its business objectives and, if so, on what basis?

Answer:

Yes, the Company does expect to be able to continue its operations and meet its business objectives based on level of planned exploration activities. Future exploration activities will be targeted and cost effective to be funded from working capital ensuring commitments are being met. Should additional funding be required, the Directors are confident that funds can be secured through future successful capital raisings.
