Conversion of Performance Rights and Cleansing Notice

Meeka Metals Limited ("**Meeka**" or the "**Company**") provides this notice under section 708A(5)(e) of the Corporations Act in relation to the issue today of 38,250,000 fully paid ordinary shares in the Company.
