Answer: No. Cash flows for the forthcoming quarter are expected to decrease relative to the prior reporting period. This reduction reflects the completion of several one-off and non-recurring expenditure items incurred in the previous quarter, together with a strategic focus on cost containment.

Answer: Yes. The entity has an extraordinarily high level of trade debtors at the end of this period which the majority has already been paid with the remainder to be received in the next month.
