NOTICE UNDER SECTION 708A(5)(e) OF THE CORPORATIONS ACT

Micro-X Ltd (ASX:MX1) ('Micro-X' or the 'Company') has today issued 18,750,000 fully paid ordinary shares in the capital of the Company (Shares) at an issue price of \$0.08 per Share.
