The company has entered into a funding facility of up to \$38.5 million from Linlithgow Family Office (LFO) to fully cover the clinical trial costs, including the associated non-clinical work and trial drug manufacturing costs for the IRX-211 and IRX-616a drug development plans through to the completion of Phase 2 clinical trials (the Facility) over the next 2-3 years. Amounts drawn down under the Facility will attract interest at 15% p.a, capitalised monthly with terms tied to the completion of Phase 2 trials for IRX-211 and IRX 616a. During the quarter, \$281,000 was drawn down under this facility. Total interest of \$48,488 has been accrued over the term of the facility The Facility can only be used to finance clinical cost. On 4 December 2025, the company announced that it had entered into a further facility for approximately \$12.6 million to fund Phase 1 and 2 cost of SRX-25, the Company's new oral Esketamine + CYP450 inhibitor fixed dose combination therapy. Nothing has been drawn down under this facility at 31 March 2026. During the previous quarter the company received \$369,000 under and its R&D funding facility. Interest is payable at 17% and a total of \$24,920 has been accrued at 31 March 2026.
