QUARTERLY ACTIVITIES REPORT AND APPENDIX 5B FOR THE QUARTER ENDED 30 JUNE 2026

Maiden USA critical minerals platform established in Montana, \$1.5 million placement completed and first-pass field programs delivered at Radix and Stibnite Ridge.

HIGHLIGHTS

- **Transformational entry into the USA critical minerals sector, with a binding agreement executed to acquire 100% of American Antimony Metals LLC, holder of the Stibnite Ridge Thompson Falls Antimony and Silver Project in Sanders County, Montana, and the direct staking of the 80-claim Radix REE and Gallium Sheep Creek Project in Ravalli County, Montana.**
- **Placement completed, raising \$1,501,084 (before costs) via the issue of 75,054,176 fully paid ordinary shares at \$0.02 per share, with a further \$82,500 director participation subsequently approved by.**
- **Mr Graham Peterson appointed Senior Geologist – USA Operations, strengthening the Company's in-country technical capability.**
- **Phase 1 targeting study completed at Radix, identifying the Beaver Creek Carbonatite-Nb Zone as the priority in-claim target, with public-domain USGS MRDS records reporting historical niobium values of up to 0.3% Nb¹.**
- **Maiden first-pass field programs completed at both Montana projects – Stibnite Ridge and Radix – with 105 samples submitted to ALS in Twin Falls, Idaho, on 8 June 2026.**
- **General Meeting held on 24 June 2026, with all resolutions passed by poll.**
- **Cash at 30 June 2026 of \$2.6 million.**

Omnia Metals Group Ltd ("Omnia" or the "**Company**") (ASX: OM1) is pleased to present its Quarterly Activities Report for the quarter ended 30 June 2026 ("**Quarter**").

The Quarter was a transformational period for the Company, marked by its entry into the United States critical minerals sector through the acquisition of the Stibnite Ridge Thompson Falls Antimony and Silver Project and the direct staking of the Radix REE and Gallium Sheep Creek Project, both in Montana, USA. The acquisitions were supported by a \$1.5 million placement, the appointment of in-country technical leadership and the immediate commencement of on-ground exploration, with maiden first-pass field programs completed at both projects before Quarter end. The Company also continued to advance its Australian

portfolio, including planning for a follow-up VTEM survey at the Ord Basin Cu-PGE-Ni Project in Western Australia.

OMNIA METALS' EXECUTIVE DIRECTOR, PATRICK GLOVAC, SAID:

"The June quarter was a defining period for Omnia. In the space of three months we entered the USA critical minerals sector with two strategically located Montana projects, completed a strongly supported placement, appointed in-country technical leadership and moved immediately on-ground, completing maiden field programs at both projects within weeks of announcing the transactions.

"With final assay results now in hand, we have clearly ranked catchments and rock occurrences to follow up at Radix, headlined by the 209 ppm niobium rock result at R017, and an initial antimony geochemical framework across our retained 28-claim position at Stibnite Ridge. We enter the September quarter with momentum, a funded work program and a clear set of priorities."

ENTRY INTO THE USA CRITICAL MINERALS SECTOR

On 15 April 2026, the Company announced a binding agreement and direct staking initiative to enter the USA critical minerals sector, strategically positioned for exposure to antimony, silver, REE and gallium in Montana, USA – one of the most strategically significant critical mineral jurisdictions in North America.

Stibnite Ridge – Thompson Falls Antimony and Silver Project (Montana, USA)

- 100% interest (via the acquisition of American Antimony Metals LLC) positioned directly on the Stibnite Hill structural corridor, directly abutting US Antimony Corp (NYSE: UAMY) and its Thompson Falls Smelter, the only DOD-approved, fully integrated antimony miner and producer in North America.
- Same host stratigraphy as UAMY's Stibnite Hill Mine, the second largest known stibnite vein deposit in the US, where high-grade antimony mineralisation has been previously mined and was restarted by UAMY in late 2025 in response to the severe antimony supply shortage in the United States.
- Highly prospective for silver at the eastern end of Idaho's Coeur d'Alene district, which accounts for approximately 18% of the USA's total accumulated silver production.

Radix REE and Gallium – Sheep Creek Project (Montana, USA)

- 100% ownership of 80 lode mining claims (~3,024 acres) in Ravalli County, Montana, directly staked via Omnia's US subsidiary Earth Elements LLC.
- Directly adjacent to US Critical Minerals' Sheep Creek project – the highest-grade REE and gallium deposit in the United States – with the Radix Project located on the same carbonatite geological trend.

Consideration for the acquisition of American Antimony Metals LLC comprised 25,000,000 fully paid ordinary shares (at a deemed issue price of \$0.02 per share), subject to shareholder

approval, which was obtained at the Company's General Meeting. The consideration shares were issued on 24 July 2026, completing the acquisition.

RADIX REE AND GALLIUM SHEEP CREEK PROJECT (MONTANA, USA)

Phase 1 Targeting Study

On 25 May 2026, the Company announced the results of its Phase 1 targeting study for the Radix Project². The study identified the Beaver Creek Carbonatite-Nb Zone as the priority in-claim field validation area, where public-domain USGS MRDS records report historical niobium values of up to 0.3% Nb associated with carbonatite and amphibolite.

The study was supported by three regional study corridors – West Fork Bitterroot, Sheep Creek and Woods Creek – used to refine the district-scale REE-Nb carbonatite exploration model, with Radix-area NURE stream-sediment data highlighting a potential drainage-scale REE target for follow-up.

Maiden First-Pass Field Program

During the Quarter, Omnia completed a first-pass geochemical and geological reconnaissance program across the Company's 80-claim Radix landholding, comprising 81 samples (45 drainage-sediment samples and 36 rock samples). Proposed drainage-sediment sample sites were generated in QGIS along selected drainages at nominal intervals of approximately 250–300 metres, with rock samples collected during prospecting traverses from outcrop, subcrop, float and other geological features considered relevant to the Project's REE and critical-mineral potential.

All samples were submitted to ALS in Twin Falls, Idaho, on 8 June 2026. Sediment samples were analysed using ALS method ME-MS81 (lithium-borate fusion, ICP-MS finish), with rock samples additionally analysed for whole-rock major elements (ME-ICP06), loss on ignition (OA-GRA05) and total calculation (TOT-ICP06).

Results

Final assay results were received and announced after the end of the Quarter³. Key outcomes include:

- Rock sample R017 returned the program-high niobium result of 209 ppm Nb – a notable discrete anomaly warranting follow-up resampling, mapping and mineralogical characterisation.
- Sediment sample PN0001175837 returned the program-high REE results of 560.43 ppm TREE + Y, 146.50 ppm Nd + Pr and 142.68 ppm HREE + Y, with coherent drainage-scale REE variation defined across several catchments.

- The results provide the first Company-generated geochemical framework for the Project and support the REE-Nb targeting model developed in the Phase 1 study.

The results are reconnaissance-scale and do not represent mineral-resource grades or demonstrate continuity. They are considered suitable for target prioritisation and follow-up source-rock investigation.

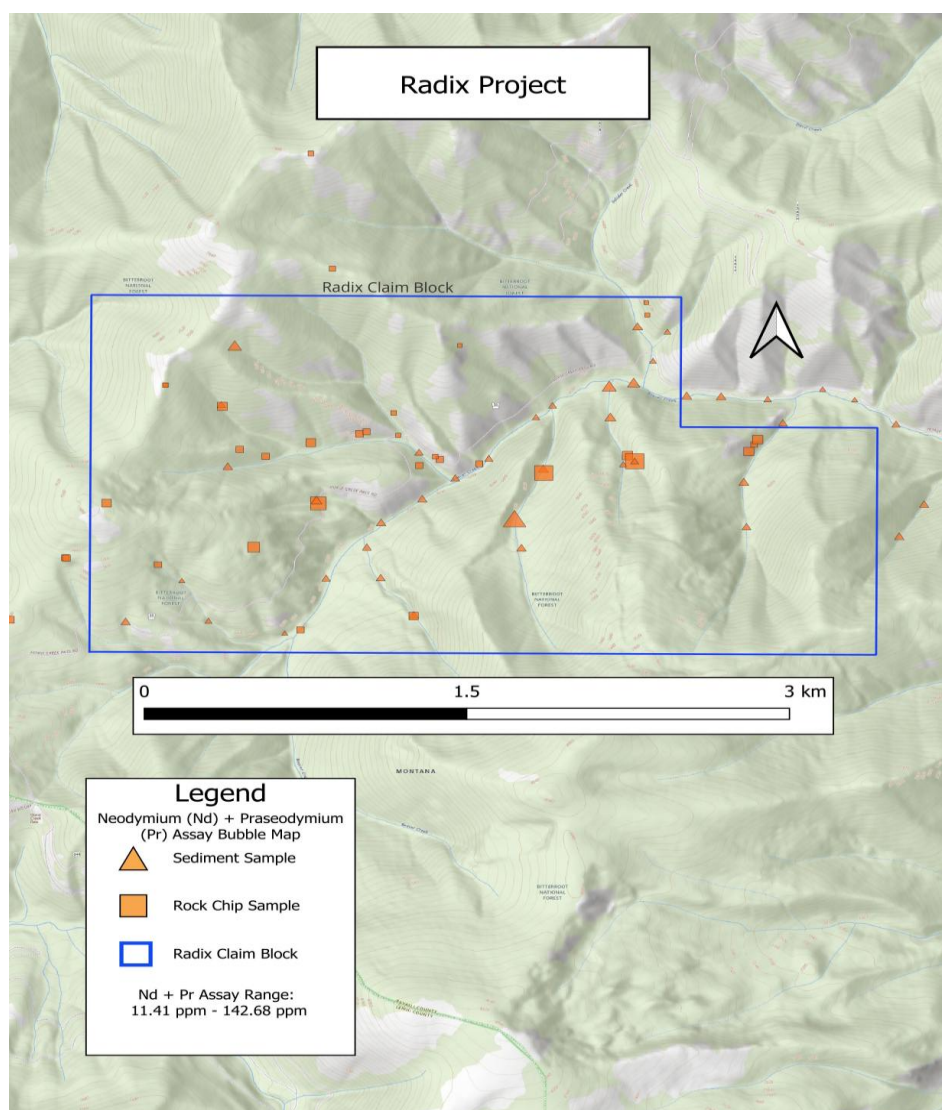


Figure 1: Neodymium + Praseodymium (Nd + Pr) proportional-symbol assay map, Radix Project.

STIBNITE RIDGE THOMPSON FALLS ANTIMONY AND SILVER PROJECT (MONTANA, USA)

Maiden First-Pass Field Program

During the Quarter, the Company completed a reconnaissance sampling program at Thompson Falls Pass in Sanders County, Montana, designed to provide an initial geochemical framework for antimony and associated pathfinder elements. A total of 24 samples were collected and submitted for laboratory analysis, with proposed drainage-sediment sites planned in QGIS at nominal intervals of approximately 200 metres along selected drainages.

Results and Tenure Update (Post-Quarter)

Final assay results were received and announced after the end of the Quarter⁴ (refer). Results were reported for the 17 samples located within the Company's current 28-claim tenure (16 drainage-sediment samples and one rock chip sample); the seven samples located outside current tenure are not reported or relied upon.

- Drainage-sediment samples returned 2.05–16.0 ppm Sb, 6.28–40.6 ppm As and 0.018–0.082 ppm Ag.
- Sample PN0001175801 returned coincident program-high antimony and arsenic values of 16.0 ppm Sb and 40.6 ppm As, while PN0001175819 returned the highest reported silver value of 0.082 ppm Ag.

American Antimony Metals located a proposed 70-claim block at the Stibnite Ridge Project in October 2025. A subsequent tenure review identified competing third-party lode claims located by a separate company over part of the proposed block. Based on the site visit observations and the first-pass reconnaissance results, the Company has elected not to contest the competing third-party claim locations and to focus on the more prospective 28 claims retained by Omnia.

The results are reconnaissance-scale and do not demonstrate continuity or economic mineralisation; any further work programs remain under assessment.

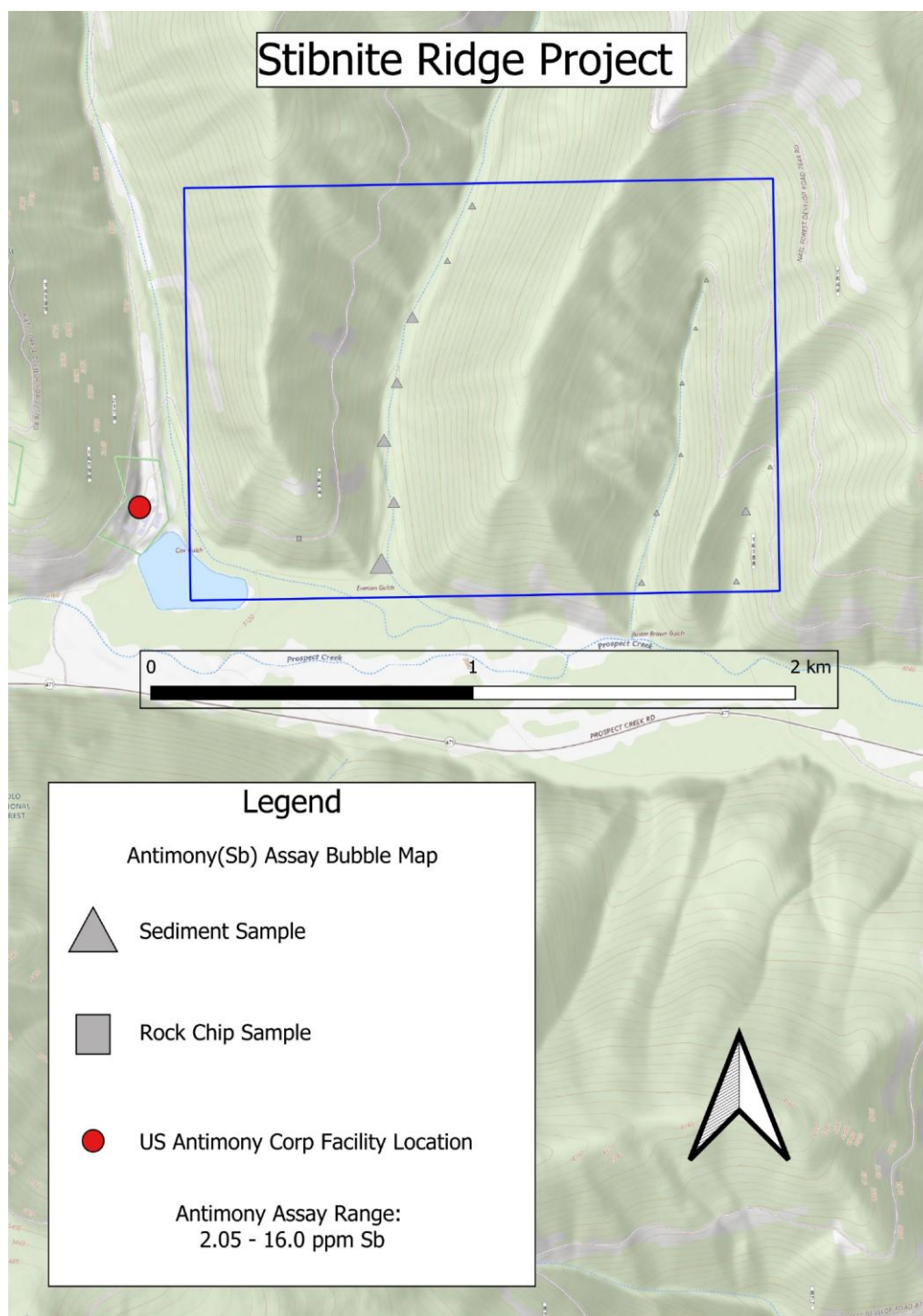


Figure 2: Antimony (Sb) assay bubble map, Stibnite Ridge Project. Only samples located within the current 28-claim tenure are shown. Reported range: 2.05–16.0 ppm Sb.

AUSTRALIAN PROJECTS

Ord Basin Cu-PGE-Ni Project (East Kimberley, Western Australia)

During the Quarter, the Company continued planning for a follow-up airborne VTEM (Versatile Time Domain Electromagnetic) survey at the Ord Basin Project, designed to refine and prioritise subsurface conductive targets for future drill testing. The Company is securing a suitable

geophysics contractor and an optimal seasonal access window, with timing subject to contractor availability, weather conditions and logistical considerations in the Kimberley region.

Salt Creek Project (Goldfields, Western Australia)

No field activities were undertaken at the Salt Creek Project during the Quarter. The Company continued to integrate geological, lithogeochemical and structural information from its earlier slim-line RC drilling program to inform future exploration targeting.

CORPORATE

Completion of Placement

On 23 April 2026, the Company completed the issue of 75,054,176 fully paid ordinary shares at an issue price of \$0.02 per share, raising \$1,501,084 (before costs). The Placement was issued in one tranche under the Company's existing placement capacity pursuant to ASX Listing Rules 7.1 and 7.1A.

Placement proceeds are being applied toward advancement of the Company's USA critical minerals portfolio – the Stibnite Ridge Thompson Falls Antimony and Silver Project and the Radix REE and Gallium Sheep Creek Project – alongside the Ord Basin Cu-PGE-Ni Project and general working capital.

General Meeting

The Company held a General Meeting of shareholders on 24 June 2026, at which all resolutions were passed by poll, including ratification of the Placement and approval of the issue of the Stibnite Ridge consideration shares, Director participation shares and attaching options, lead manager options, Director incentive options and performance rights.

Cash Position

At the end of the Quarter, the Company held cash of approximately \$2.6 million. The Company remains funded to advance its USA critical minerals portfolio, progress the Ord Basin VTEM survey and for general working capital.

POST-QUARTER EVENTS

On 24 July 2026, the Company announced final assay results from the maiden first-pass programs at Radix and Stibnite Ridge, together with the Stibnite Ridge tenure update, as summarised above.

On 24 July 2026, the Company issued all securities approved at the General Meeting, comprising 29,125,000 fully paid ordinary shares (25,000,000 Stibnite Ridge consideration shares at a deemed issue price of \$0.02 and 4,125,000 Director participation shares at \$0.02), 17,898,335 unlisted options (2,062,500 Director attaching options and 15,835,835 lead manager options), 12,500,000 Director incentive options and 6,375,000 performance rights. The issue of the consideration shares completed the acquisition of American Antimony Metals LLC and the Stibnite Ridge Project.

Following these issues, the Company's capital structure comprised 406,895,879 fully paid ordinary shares, 306,816,094 quoted options (OMIO), 35,250,000 performance rights.

SEPTEMBER QUARTER OUTLOOK

Planned activities for the September 2026 quarter include:

- Integration of the Radix sediment and rock assay results with field observations, radiometric traverses, regional geology and magnetic datasets, and prioritisation of catchments and rock-sample clusters showing coincident TREE + Y, Nd + Pr, HREE + Y and/or Nb responses.
- Follow-up work at the R017 niobium anomaly and other high-priority Radix rock locations, including representative resampling, mapping and petrographic or mineralogical characterisation.
- Tighter-spaced upstream sediment sampling in selected Radix drainages to vector toward potential bedrock sources, with Company-inserted certified standards, blanks and field duplicates in subsequent programs.
- Ongoing assessment of the 28 retained claims at Stibnite Ridge.
- Completion of contracting and scheduling for the Ord Basin VTEM survey, subject to contractor availability and seasonal access.
- Continued evaluation of additional advanced-stage critical minerals opportunities in the United States.
