ISSUE OF SHARES

PolarX Limited (ASX:PXX) ("the Company") advises that it has issued 1,588,794 ordinary shares ("Shares") at a deemed issue price of \$0.025 per Share, to a contractor in consideration for services rendered in relation to the Humboldt Range Gold Project.
