Notice of initial substantial holder

SIV Capital Limited (SIV), in accordance with our continuous disclosure obligations, attaches a Form 603 Notice of Initial Substantial Holder lodged by Wavet Fund No 2 Pty Ltd ATF Wavet Super Fund No 2 & Glenn Molloy (**Wavet**) in relation to Wavet's acquisition of a relevant interest in 7.36% of the voting shares in the Company in late August and early September 2025.

The Company has been advised that the Form 603 was not lodged at the time of acquisition as the Company's securities were suspended from quotation, and Wavet did not appreciate that a substantial holding notice was still required notwithstanding that the Company's shares were not then capable of being traded on market.

The Company can confirm that outside the relevant transaction, there was no trading in its securities during the period between Wavet's acquisition of the relevant interest and the lodgement of the attached Form 603.

DIRECTIONS
