Note 1: On 5 November 2025, shareholders of Spacetalk Ltd approved the issue of \$1,000,000 of interest-bearing Converting Notes, convertible into ordinary shares at a conversion price of \$0.08 per share. Interest accrued on the Converting Notes at the rate of 10% per annum from the date of issue until redemption or conversion. On the Redemption Date of 31 July 2026, the Converting Notes were converted in accordance with their terms into ordinary shares at the approved conversion price of \$0.08 per share, and the unpaid interest was satisfied by the issue of ordinary shares at an issue price calculated at the VWAP, determined in accordance with the terms of the Converting Notes.
