

Operational Update

Middle East Delivery Accelerates as Airspace Restrictions Lift

Highlights:

- United Arab Emirates (UAE) airspace restrictions lifted following GCAA and DCAA confirmations, supporting a return to business-as-usual operating conditions across the region, facilitating the commencement and progression of project activities under recently awarded contracts.
- ACE-S-200 ROV deployed at AD Ports to survey vessels below the waterline, capturing critical visual and asset condition data from hard-to-access areas
- BoltEx® sales increase compared to same period in prior year, reflecting growing demand for the product across the Group's portfolios
- Company well positioned to convert an expanding Middle East pipeline into sustained revenue growth as further call-offs are issued

SRJ Technologies Group Plc (ASX: SRJ) ("SRJ" or the "Company") is pleased to provide an operational update, with UAE airspace restrictions now lifted, Air Control Entech LLC ("ACE") field teams mobilising under existing framework contracts and BoltEx® sales milestones.

Middle East Activity Resumes as Restrictions Ease

Following the recent easing of airspace closures and restrictions across the UAE, SRJ has seen immediate client activation of previously announced agreements in the region (see announcement dated 2 July 2026). This follows confirmation from the General Civil Aviation Authority (GCAA), under Safety Decision 2026-03 dated 30 June 2026, that the temporary suspension of unmanned aircraft systems (drones), light sport aircraft, and balloon operations within UAE airspace has been phased out, alongside a separate notice from the Dubai Civil Aviation Authority (DCAA) confirming the resumption of airspace activities within the Emirate of Dubai, subject to operators maintaining compliance with applicable regulatory requirements, approvals, and operational conditions.

This regulatory clearance provides a clear runway for SRJ to accelerate conversion of its regional pipeline into active work. With deployment now progressing, the Company expects activity levels across its Middle East contracts to build steadily over the coming months as further call-offs are issued.

Mobilisation at AD Ports

Mobilisation is now underway at AD Ports, with field teams from SRJ subsidiary Air Control Entech Survey LLC ("ACE") delivering robotic inspection and integrity services under existing framework contract with Divetech Marine Engineering Services.

The Company's ACE-S-200, which is a mission-ready expeditionary underwater ROV platform designed for rapid deployment and precision inspection, is being used to survey vessels below the waterline.

The technology captures critical visual and asset condition data from areas that are difficult, hazardous, or inefficient to access using traditional methods, giving the customer reliable operational data to inform decisions on the vessel's readiness for continued operations.

By removing the need for divers or in-water personnel, the approach reduces human exposure and operational risk while delivering the data quality needed to extend safe in-field operations.

This marks the start of delivery under SRJ's recently announced SLA with Divetech and reflects the Company's growing presence across the Middle East's maritime and energy infrastructure sectors.

BoltEx® Update

The Company continues to see momentum in sales of its BoltEx® flange clamp system, with new and repeat orders secured across multiple regions during the current financial year.

BoltEx® sales for the first half of the year stand at circa 80% of total sales recorded for the full 2025 financial year, with the product increasingly being adopted by operators across energy, aerospace and industrial environments where safely minimising downtime during hot bolting operations is critical.

Commenting on the updates, Kurt Reeves, Chief Executive Officer of SRJ Technologies, said: *"This has been a period of real momentum for SRJ. The easing of aviation restrictions in the UAE allows us to move straight into delivery on contracts we have worked hard to secure and we have moved immediately to mobilise field teams and activate agreements under our existing framework contracts. We see this as a significant opportunity for the Group. With regional operators returning to normal activity levels and our contracts secured, we are well-positioned to convert our expanding Middle East pipeline into sustained revenue growth over the coming months."*

"We are also pleased to see the progress the business is making across the portfolio, with BoltEx® sales steadily increasing year on year. This further reflects the strength of the platform we are



building across the asset integrity lifecycle and this continued momentum across our broader portfolio of products and services gives us confidence in the outlook for the remainder of the year.”
