The facility at 30 June 2026 was for up to \$2 million, Interest rate on drawings is 8%, and the facility is repayable on 31 March 2027 and is unsecured. As at 30 June 2026 the facility was drawn to \$nil. No funds were drawn on the facility during or since the end of the Quarter. The Company has a loan facility provided by Norfolk Enchants Pty Ltd, an unrelated third party. The facility principal was for up to \$6m, has an interest rate of 20% per annum and is currently due for repayment. The facility is secured by a fixed and floating charge over the assets of the Company. As at 30 June 2026 the amount due on the facility was \$1,623,000 and no further amounts are currently available to be drawn under this facility. Principal and interest payments of \$nil were made by the Company in the Quarter with an agreed repayment plan in place for the remaining loan balance.
