8.8.1 Does the entity expect that it will continue to have the current level of net operating cash flows for the time being and, if not, why not?	
Answer: Yes. The March quarter included the payment (\$375k) to the vendors of the Yaounde West project, which was outside of normal operating expenses. A further \$375k is payable on the granting of the Yaounde West licences.	
8.8.2 Has the entity taken any steps, or does it propose to take any steps, to raise further cash to fund its operations and, if so, what are those steps and how likely does it believe that they will be successful?	
Answer: As announced 17 April 2026, the Company entered into a sale agreement with AuKing Mining Limited (ASX:AKN) regarding the sale of the Company's Tundulu REE project in Malawi. At completion, the Company will receive a cash payment of \$1.25 million, with an additional \$1.1 million 6 months post completion and a further \$1.1 million 12 months post completion. The cash proceeds from the sale of Tundulu are considered sufficient to meet the Company's cashflow needs.
