Vysarn Limited – request for trading halt

Vysarn Limited (ASX: VYS) (the **Company**) requests a trading halt of the Company's ordinary shares from the commencement of trading on Tuesday, 2 June 2026.

Pursuant to ASX Listing Rule 17.1, the Company provides the following information in connection with this request:

- the trading halt is requested pending an announcement in relation to a potential material acquisition;
- the Company anticipates that the trading halt will end on the earlier of a release of an announcement to the market in relation to the material acquisition, and the commencement of normal trading on Wednesday, 3 June 2026, and requests that the trading halt remain in place until that time;
- the Company is not aware of any reason why the trading halt should not be granted; and
- the Company is not aware of any other information necessary to inform the market about the trading halt.
