Quarterly Activities Report**Q3 FY26 headlines:**

Wingara AG Limited (ASX: WNR), is pleased to provide its 31 December 2025 quarter's activities report alongside its Appendix 4C (Quarterly Cashflow Report) for the nine months ended 31 December 2025 (Q3 FY26).

During the quarter, Wingara continued to manage its reduced operating cost base following the cessation of export hay processing operations and the sale of its main hay processing assets, which was completed following shareholder approval earlier in the financial year. As at 31 December 2025, the Company remained focused on managing its remaining obligations at the Epsom site, including ongoing lease, site maintenance and make-good requirements ahead of the scheduled expiry of the lease in February 2026.

Notwithstanding the reduction in export processing operations, Wingara retains the capability to undertake domestic hay trading activities, storage coordination and logistics management services as a core business. The Board and management are focused on reviewing transaction opportunities whilst organically rebuilding activity by leveraging their experience, supplier relationships and operational knowledge across hay procurement, storage, customer coordination, transport planning and third-party service provider management.

For the quarter ended 31 December 2025, Wingara reported receipts from customers of \$63,000 and net cash used in operating activities of \$58,000. Cash and cash equivalents at 31 December 2025 were \$412,000.

During the quarter, the Company received a \$250,000 loan from NAOS, as previously disclosed on 23rd December 2025. Refer to the ASX release [here](#). The loan has been reflected in the Appendix 4C as proceeds from borrowings for the quarter. The proceeds provide additional working capital support as the Company continues to manage its Epsom site obligations, corporate costs and organic business development activities.

In accordance with ASX Listing Rule 4.7C.3, payments to related parties and their associates outlined in the Company's Appendix 4C for the quarter relate to fees and salaries paid to Directors.
